**A RESOLUTION AWARDING BID FOR RENOVATION OF
JIM "PEANUT" DAVENPORT FIELD AND STADIUM**

WHEREAS, The City Council of the City of Alabaster, Alabama has adopted the fiscal year 2023 budget funding certain projects including the renovation of Jim “Peanut” Davenport Field and Stadium; and

WHEREAS, the Mayor and City Council of the City of Alabaster wish to provide safe and efficient family outdoor amenities and exercise facilities; and

WHEREAS, pursuant to Alabama Code § 39-2-2, the following one (1) bid was received for a bid opening on Thursday, May 25, 2023, at 2:30 PM:

WHEREAS, City Administration and CMH Architects have recommended awarding the bid for renovation of Jim “Peanut” Davenport Field and Stadium to **Clements Dean Building Company** in the amount of **\$8,997,000.00** plus an incentive of up to **\$50,000.00** with a total not to exceed **\$9,047,000.00**.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Alabaster, Alabama:

- 1. The City Council awards the bid to **Clements Dean Building Company, LLC** and authorizes renovation of Jim “Peanut” Davenport Field and Stadium in the amount of **\$8,997,000.00** plus and incentive of up to **\$50,000.00** with a total not to exceed **\$9,047,000.00**
- 2. The City Council acknowledges the Finance Director, if needed, may make the necessary general fund expense line adjustments to stay in fiscal balance.
- 3. The City Council also permits Scott Brakefield, Mayor, and Mark Frey, City Clerk, to execute and attest all documentation necessary to complete this transaction.
