**A RESOLUTION AWARDING THE BID FOR A RE-TURF PROJECT  
LOCATED IN ALABASTER’S LARRY SIMMONS STADIUM**

**WHEREAS**, The City Council of the City of Alabaster, Alabama has solicited sealed proposals pursuant to Sections 39-2-2, et al., CODE OF ALABAMA on June 20, 2025, for a **Re-Turf Project Located at Alabaster’s Larry Simmons Stadium**; and

**WHEREAS**, this project was included in the FY2025 budget, and the following bids were received:
