## **ORDINANCE 25-227**

## AN ORDINANCE TO PRE-ZONE PROPERTY OWNED BY JACK WREN LOCATED AT 1857 MASSEY RD TO E (SINGLE-FAMILY ESTATE RESIDENTIAL DISTRICT)

THE PUBLIC GOOD REQUIRING IT, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALABASTER, ALABAMA AS FOLLOWS:

**WHEREAS** on February 22, 2025, **Jack Wren** as the property owner, did file with the City Planner a petition asking that should said tract or parcel of land be annexed to and become a part of the City of Alabaster, Alabama; then such property be pre-zoned to **E** (Single-Family Estate Residential District) pursuant to Ala. Code § 11-52-85.

**WHEREAS** the Planning and Zoning Commission held a public hearing on this matter on March 25, 2025, and did recommend to the Council that said property located at 1857 Massey Rd (22 3 05 4 001 001.008) be zoned to E (Single-Family Estate Residential District) without condition should same be annexed.

That this proposed Ordinance was advertised for two (2) weeks in the Shelby County Reporter, a newspaper of general circulation within the City Limits of the City of Alabaster as required by law, and that the City Council of the City of Alabaster, at its Public Hearing on May 12, 2025 at 6:30 PM, considered said proposed Ordinance and that at such time and place all persons who desired had an opportunity to be heard in favor of or in opposition to such Ordinance.

**THEREFOR, BE IT ORDAINED** that the Zoning Ordinance of the City of Alabaster, Alabama and the zoning map adopted therewith, is hereby amended to pre-zone the parcels of property recited herein to show that immediately upon annexation into the City of Alabaster said property shall be zoned to E (Single-Family Estate Residential District).

All other items and provisions of the Zoning Ordinance of the City of Alabaster not herein specifically amended shall remain in full force and effect.

This Ordinance shall become effective upon its passage and execution as provided by law.
