RESOLUTION 032723-F

AUTHORIZING MAYOR TO SIGN A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE ALABAMA DEPARTMENT OF TRANSPORTATION (ALDOT) FOR PHASE II OF THE SR119 IMPROVEMENTS DOWN TO COUNTY HIGHWAY 12

WHEREAS, the Alabama Department of Transportation (“ALDOT”) has requested the City of Alabaster, Alabama execute a resolution and Memorandum of Understanding (MOU) regarding funding of Phase II for the widening of SR119 from Silver Creek Parkway to Shelby County Highway 12, Exhibit “A” attached hereto, and

WHEREAS, the Birmingham Metropolitan Planning Organization (MPO) has already approved \$1,200,000 of Surface Transportation Program – Birmingham Attributable (STPBH) funding for the right-of-way phase of the subject project, and

WHEREAS, in addition to this funding, this project has been programmed in the Fiscal Year 2024 to 2027 Transportation Improvement Program (TIP): Utility Phase \$500,000 STPBH and Construction Phase \$5,000,000 STPBH, totaling \$6,700,000 of STPBH funding, and

WHEREAS, funding for Phase II is projected as follows:

WHEREAS, the City Council has considered the request of ALDOT to authorize the Mayor to enter said MOU and to permit the funding of the aforementioned agreement identified herein, and

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Alabaster, Alabama, at a regular meeting, duly assembled, a quorum being present, as follows:

- 1. That the Mayor is hereby authorized to execute said Memorandum of Understanding (MOU), which is before this Council, with the Alabama Department of Transportation.
- 2. That the agreement be executed in the name of the City, by its Mayor for and on its behalf and the signature of the Mayor be attested by the City Clerk and that the seal of the City be affixed to the agreement.
- 3. That this resolution shall become effective immediately upon its adoption by the City Council of the City of Alabaster, Alabama, and posting as required by law.

BE IT FURTHER RESOLVED, that upon the completion of the execution of the Agreement by all parties, that a copy of such Agreement be kept on record by the City Clerk.

WHEREAS, the Alabama Department of Transportation desires to improve Alabama Highway 119 in Alabaster from Silver Creek Parkway to Shelby County Highway 12.

In partnership with the City of Alabaster, the Alabama Department of Transportation will commit \$5,000,000.00 of Federal funds toward the construction of additional lanes on Alabama 119 within the above project limits.
