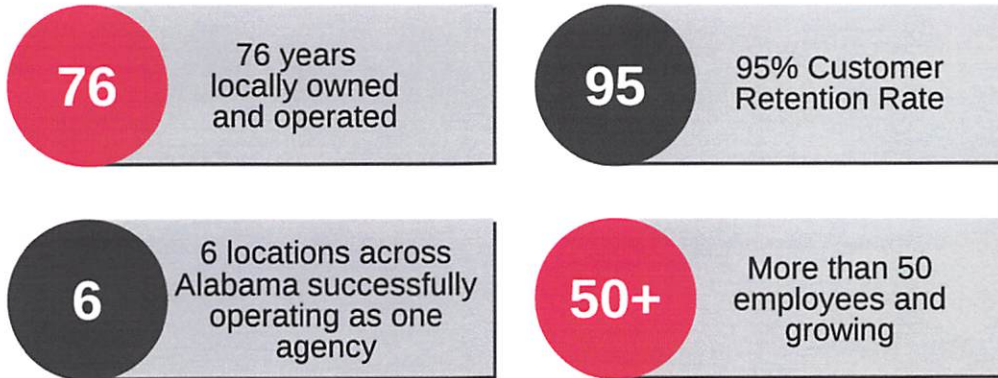

Mr. Griggs,

The police liability had a significant increase this year. Our company had research done and our rates were significantly lower than the industry standards. With the current climate with law enforcement, we have been told that we need to charge at least \$1,000 for each employee of law enforcement. I asked for permission to get to that rate in 2 years in lieu of just one year and am only charging \$800 per employee on the quote. Also, there will be no dividend at this time. We have a new Board of Directors and they want to review an entire year of financials before they make their decision. That meeting will be in July. We will know at that time if or what the dividends will be.
