**RESOLUTION NO.080320-H**

**A RESOLUTION APPOINTING ELECTION OFFICERS  
FOR THE 2020 MUNICIPAL ELECTION**

**WHEREAS**, a regular municipal election has been called to be held on Tuesday, the 25<sup>th</sup> day of August, 2020, and a runoff election to be held if necessary, on Tuesday, the 6<sup>th</sup> day of October 2020, and

**WHEREAS**, Section 11-46-27 of the Alabama Code of 1975, and regulations adopted pursuant thereto provide, in part, that the municipal governing body, not less than 15 days before the holding of any municipal election, appoint from the municipality, officers to hold election as follows: where electronic ballot counters are used, at least one inspector and three clerks.
