**RESOLUTION 071023-A**

**A RESOLUTION APPOINTING MEMBERS OF THE ALABASTER DOWNTOWN REDEVELOPMENT AUTHORITY**

**WHEREAS**, by Resolution 041023-B, upon proper petition to the City Council the City Authorized the formation of the Alabaster Downtown Redevelopment Authority of the City of Alabaster pursuant to Ala. Code § 11-54A-7; and

**WHEREAS**, Ala. Code § 11-54A-7; requires the City Council to appoint directors who shall be residents of the municipality and shall be elected by the governing body for staggered terms of office as follows: The first term of one third of the directors shall be two years; of another one third, four years; and of the remaining one third, six years. Thereafter the term of office of each director shall be six years; and

**WHEREAS**, each director so appointed shall continue to serve until their successor is appointed, qualified and seated, or serve until they resign, die, become incapable of acting as a director, or cease to reside in the municipality, or no longer qualified by becoming an officer of the state or of the municipality; and

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Alabaster, Alabama, as follows:

1. **Cedric Burden**, who is a resident of the City of Alabaster and is not an officer of the state or of the municipality is hereby appointed to **Place 1** for the term indicated below:
2. **Eve Hulsey**, who is a resident of the City of Alabaster and is not an officer of the state or of the municipality is hereby appointed to **Place 2** for the term indicated below:
3. **Andrea Holsomback**, who is a resident of the City of Alabaster and is not an officer of the state or of the municipality is hereby appointed to **Place 3** for the term indicated below:
4. **Mike Myers**, who is a resident of the City of Alabaster and is not an officer of the state or of the municipality is hereby appointed to **Place 4** for the term indicated below:
5. **Casie Jarman**, who is a resident of the City of Alabaster and is not an officer of the state or of the municipality is hereby appointed to **Place 5** for the term indicated below:
