Chief Schrimpsher - DOJ notified us that we have funding for an additional officer. We are hoping to keep this position past the grant funding with the population increase we are expecting. Two officers in field training. They will be sworn in at the next meeting. We are doing no shave November and painted fingernails if they'd like. Officer Johnson is going to Auburn December 1st. Blue Christmas is December 9th. Five families identified for gifts to be delivered. Doing a city wide banquet instead of our own this year.

City Administrator Griess - Elected Officials Training is on December 9th. Budget amendment at the next meeting for street retainage and City Admin position. Staff banquet will be December 7th from 12:00 to 2:00. Tree lighting will be December 9th from 5:00 to 7:00. Hoping to have an ordinance next meeting on a traffic impact fee. The City has been selected for direct funding from DNR through their forestry program. We will be asking for it to fund our seasonal parks position. Mayor Linnell - Recognized by RMSA and Russ has been here one year today.

A. 2024 Property Tax Ordinance

Tara Dunford presented the property tax ordinance with a 1% increase.

B. 2024 Olympic Environmental Resources Agreement

The City utilizes Olympic Environmental Resources (OER) every year to manage our annual recycling event and the grant reporting that comes with it. This agreement is for services in 2024.

C. Algona Police Officers Contract Memorandum of Understanding

Chief Schrimpsher gave a update on on the agreement that he and the Algona Police Officers Association have that would change the language in the current contract to include merit pay step increases.

D. Change to WaFed Bank

City Administrator Griess briefed the council on moving from Umpqua Bank to WaFed Bank.

E. Auburn 2024 Water Rate

City Administrator Griess briefed that the City has received notice that Auburn will be raising the wholesale water rate by 2.5%. The last water rate increase was also for 2.5% and took effective January 2022.

F. Ordinance 1228-23, Sewer Rate Increase for 2024

City Administrator Griess briefed the council that City has received notice that King County will be raising the sewer rate by 5.75% in 2024. The last sewer rate increase was for 7.5% and took effect June 2023. This increase was to catch up the 5.75% increase for 2023 and a little extra to go towards a sewer assessment

G. Resolution 1266-23, Get Active Stay Active King County Grant Agreement

The City has been granted \$5,000 to implement healthy living programs. Gary is working with the Community Center Advisory Board to determine the best options for the community whether it's a Zumba class, healthy cooking class, or scholarships for the Skyhawks sports camps.

H. WA Department of Commerce Middle Housing Grant Agreement

The City has been awarded \$35,000 for activities that support the preparation and adoption of policies and/or codes and other measures specific to implement middle housing (RCW 36.70A.030(26)) by applicable statutory deadlines. This work will support the Comprehensive Plan middle housing work by Atwell.
