**RE: Town of Alpine AMI Project- Meter Materials**

Mayor Green,

In response to the above-mentioned project, we have completed our review of the quote and due diligence process. As you are aware, one eligible bid was received for provision of meter materials. A bid for these meter materials was received from H.D. Fowler prior to this bid being advertised. The meter materials specified by H.D. Fowler are not compatible with the rest of the AMI system and therefore did not meet the required specifications of the project. Consequently, the apparent low bid was provided by Core & Main out of Idaho Falls, ID. Their bid was reviewed, evaluated & found to be complete and in accordance with the project requirements. A summary of the bid is attached. The submitted total bid amount was \$134,214.02.

The Town has secured funding for this project including an ARPA grant of \$771,400 and the Town's match commitment of \$500,000. In consideration of engineering, permitting, legal and survey costs, the proposed project budget allows for a construction budget of approximately \$984,400 with \$98,500 designated for contingency. Core and Main's bid falls under the allotted budget for this project, which allocates approximately \$500,000 for purchasing the meters to be installed by Town Staff.

We contacted Core and Main's references on similar projects and received very positive feedback. Based on the other local projects that Core and Main has completed within the area and the qualified subconsultants and suppliers they provided, we are confident that they have the ability to perform the work. We hereby recommend awarding the provision of meter materials to Core and Main for the bid amount of \$134,214.02.
