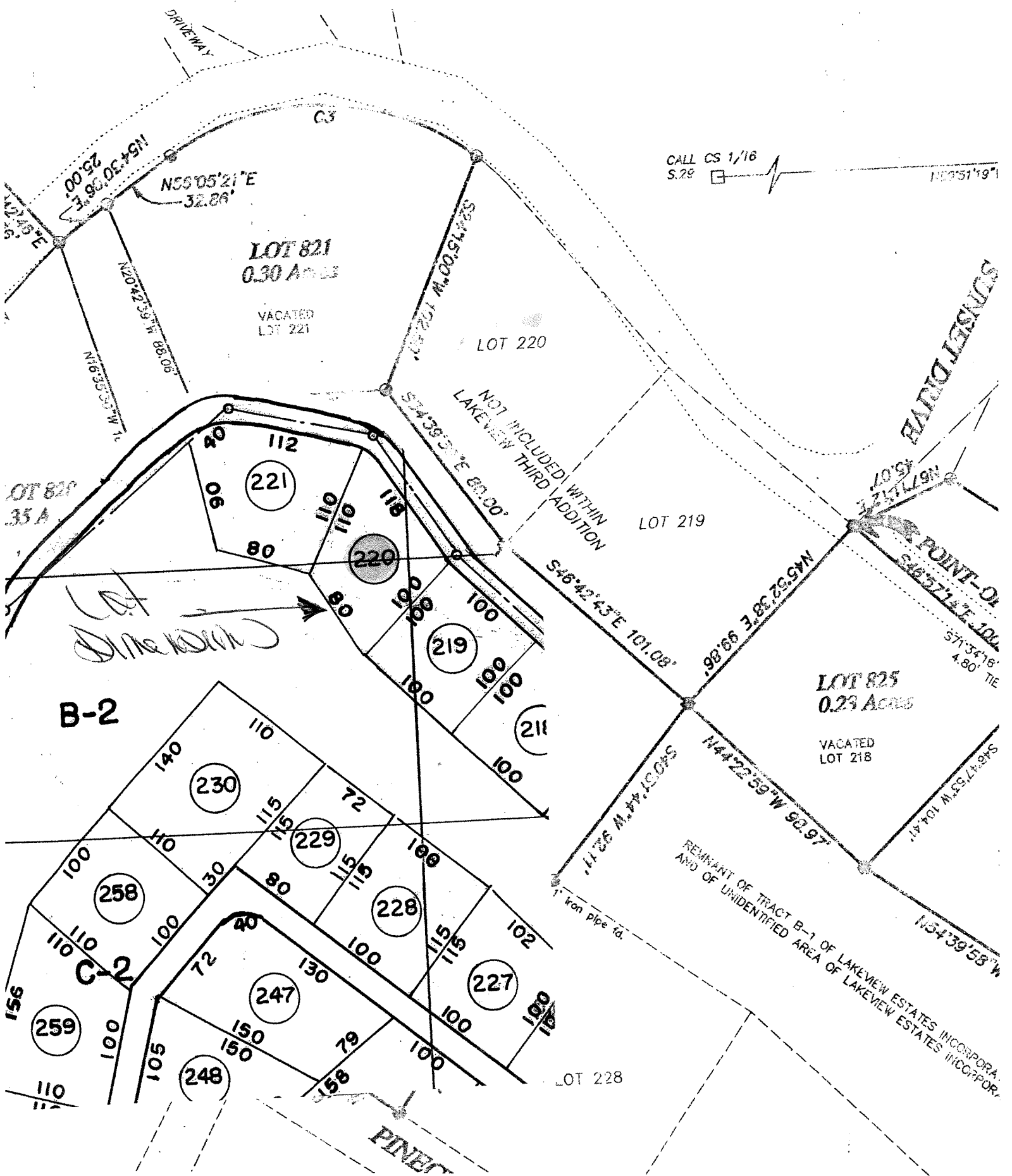
The standard billing fee, per customer, per month will be effective the first full month after installation of the meter and service.

By signing below, I understand and agree to the following:

1. Owner(s) is responsible to pay for and install water pipe from the water meter to any dwelling.
2. All contractors and subcontractors must obtain a Town of Alpine Business License.
3. The property owner(s) are responsible to have all licensed contractors, and licensed subcontractors, request a water main locate prior to any digging. Requests can be made by calling the Town Office who will notify the Alpine Maintenance or designee.
4. The owner(s), contractor(s), or subcontractor(s) will be responsible for any damage to the Town of Alpine's property and/or damage incurred by the owner(s), contractor(s), or subcontractor(s).
5. Failure to schedule and complete a water main locate will result in added liability of the owner(s), contractor(s), or subcontractor(s) and may result in a fine.
6. The Town requires owner(s) to install a shut off valve on the owner(s) side of the water pit with a standpipe.
7. Whatever size of connection you pay for, your line from your house to the water pit must be of equal size and diameter.
8. The Customer of the property shall install and be responsible for the service line from the existing Town of Alpine curb stop (or inlet of the meter pit) to future building(s) located on the property. The meter will be furnished by the Town of Alpine and the Town of Alpine will also be responsible for the meter. The customer shall install the meter reading touch pad for the meter in an easily accessible location **NEAR THE ENTRANCE OF THE HOME** and above the snow line for the Town of Alpine's staff to perform meter readings.
9. It is highly recommended that a shut off valve is located at the point of entry into the dwelling.
10. If connection to the Town water system is not completed within one year from the date of payment, I understand my application will expire and a new one will need to be filled out and the applicable fees paid.
