#### **Recommendations for a safer work environment:**

- Secondary containment of workplace labeling to include "product identifier and words, pictures, symbols, or
  combination thereof, which provide at least general information regarding the hazards of the chemicals, and
  which, in conjunction with the other information immediately available to employees under the hazard
  communication program, will provide employees with the specific information regarding the physical and
  health hazards of the hazardous chemical."
- Update Safety and Health programs. Train employees to the expectations of the programs in place. Document training.
- Training employees in safety programs is crucial for several reasons:
  - Reduces Workplace Accidents: Effective safety training can significantly lower the number of workplace accidents and injuries, leading to a safer work environment. Implementing safety training programs is a proactive measure that can lead to increased productivity morale, and operational efficiency within an organization.
- Ensure fire extinguishers are inspected and logged every 30 days.
- Store propane bottles outside of the shop.
- Ensure light conditions are adequate for working within the Headworks building. (out of commission)
- Locking the Waste water building (out of commission) to avoid unauthorized persons from entering.
- Inspect all fall arrest equipment prior to use.
- Determine weight of yellow grating panels in the new waste water facility.

## Best practices observed during the inspection:

- Housekeeping within the current Waste Water facility demonstrates the workgroups commitment to safety.
- The Town of Alpine is committed to improving their safety culture.

#### Elements of an effective health and safety program:

- Management commitment and employee involvement
- Worksite analysis
- Hazard prevention and control
- Safety and health training

#### **Specialist Comments:**

The Town of Alpine has a great communication system within their departments. Employee dedication is evident in the daily operation of the facility. Thank you for working with Workers Compensation Safety and Risk. WCSR is available to assist in additional program review and awareness training.

Once the identified hazards have been corrected, all abatements must be received by **WCSR** 6 weeks (42 days) following the last day of the visit.
