Dear Ms. Corson,

My neighbors and I appreciate that you only joined the Town staff about 6 months ago and that this survey was conducted before your time. A survey that captures less than 10% of the population and did not intentionally reach out directly to concerned neighbors to seek input does not seem to be trying to take our concerns into account. We also appreciate that you have sent us the information about these latest actions *via* legal notice and provided us with a chance to respond via public comment on the replatting and special use permit.

I am very surprised that a similar action was not taken before the town signed a lease with a school for land next door to us. Do you have a copy of the lease that was signed that you can share with us? What provisions are included in the lease protect the town if the replatting and special use permit decisions are not passed by the town council? Or has the Town Council already decided they are going to *move* ahead with this regardless of what the community thinks?

I invested in my property 20 years ago as my planned retirement home. I have been serving our country in various countries- including Iraq, Pakistan, and other places where my life was at risk- for 21 years, dreaming of when I can retire from public service to a peaceful home in Alpine. I retire later this year, and I am distraught to realize that my dreams may never come to reality because of this town decision, one that may negatively impact the quiet I seek as well as the property value of my home. The skate park and its trespassing users was bad enough, with the town taking no responsibility to protect our property, a tradition I fear being the same for this new neighbor that will be more intrusive.

The additional questions so have include-

1. What efforts has the town made to identify other properties that would be equally suitable for this school?
2. Why was this property chosen over the other options?
3. Why is this moving forward before the new master planning process is complete?
4. What is the environmental, water usage, and sewage impact of this school on the natural landscape?

I am writing in opposition to the proposed replatting and special use permit that would allow the Alpine Education Foundation to place used modular buildings on

newly created Lot 15 for the purpose of a charter school.

I respectfully urge the Town to **wait until the new Master Plan is complete** before making long-term land use decisions. The current 2006 plan is nearly 20 years old. A project of this magnitude should not be rushed ahead of updated community priorities and planning data.

I also raise the following concerns:

1. **Safety:** The existing skate park next to my townhouse has already created unsafe conditions, with children cutting through our private parking lot to reach it. A charter school would multiply this danger by adding hundreds of daily vehicle trips and pedestrian crossings. I ask the Town: *How will you protect children and residents from these hazards if this project moves forward?*
2. **Survey Transparency:** The Town's Master Plan report cites a survey showing 77% support for a charter school. Yet neither I nor my neighbors recall ever receiving such a survey. I request full transparency: the number of respondents, distribution methods, and the dates the survey was conducted. Without this, the survey results cannot be considered statistically valid.
3. **Public School Resources:** Charter schools divert taxpayer dollars from public schools, which provide a stronger, more equitable education. Our community schools need strengthening, not fragmentation. *Why are we not funding a public school and instead relying on a substandard option for our community children's education?*

For these reasons, I strongly oppose approval at this time. The Town should pause until the new Master Plan is finalized, conduct a valid and transparent survey, and address safety and resource concerns.
