Angleton City Council,

I am writing to formally request a waiver of the application fee associated with the Special Use Permit (SUP) for temporary on-site dwelling in a recreational vehicle at my property, located at **202 S Walker St** (Property ID: 264090).

This request is made due to extraordinary and compassionate circumstances involving a severe family medical crisis.

My mother, Laura Green, has recently been diagnosed with **Stage 4 metastatic breast cancer** and is no longer able to live independently. As I detailed in my initial request to the Development Services Department, I have placed an RV on my property to provide her with **immediate and essential care** for the anticipated duration of six months to one year. This arrangement is the only way I can accommodate her critical needs while providing a measure of comfort and personal space during this difficult time.

Given the extreme and unforeseen financial and emotional hardship placed upon my family due to this medical emergency, I respectfully ask the City Council to grant a waiver for the standard SUP application fee. Approving this waiver would significantly assist my family in managing the costs associated with caring for my terminally ill mother.

I have all necessary information regarding the temporary exception request and am fully prepared to comply with all conditions the City may impose regarding the placement and maintenance of the RV to ensure neighborhood safety and aesthetics.

I understand that the City Council holds the sole authority to grant such a waiver, and I sincerely appreciate your consideration of my family's unique and urgent circumstances.
