ORDINANCE NO. 20210413-009

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS, AMENDING THE CITY OF ANGLETON CODE OF ORDINANCES TO UPDATE STATE LAW REFERENCE CITATIONS THAT HAVE BEEN CHANGED BY THE TEXAS LEGISLATURE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY; AND PROVIDING FOR REPEAL AND EFFECTIVE DATE.

WHEREAS, the City of Angleton Code of Ordinances contains several citations to Texas laws that have subsequently been renumbered by the Texas Legislature; and

WHEREAS, amending the City of Angleton Code of Ordinances to update the citations to the correct numbering will alleviate confusion caused by the outdated citations;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS:

SECTION 1. The facts recited in the preamble hereto are found to be true and correct.

SECTION 2. The outdated citations throughout the City of Angleton Code of Ordinances are amended to the current, correct citations, as outlined in the attached exhibit A.

SECTION 3. All ordinances or parts of ordinances inconsistent with the terms of this ordinance are hereby repealed; provided, however, that such repeal shall be only to the extent of such inconsistency and in all other respects this ordinance shall be cumulative of other ordinances regulating and governing the subject matter covered by this ordinance.

SECTION 4. In the event any clause, phrase, provision, sentence or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Angleton, Texas declares that it would have passed each and every part of the same notwithstanding the omission of any part thus declared to be invalid or unconstitutional, or whether there be one or more parts.

SECTION 5. That this Ordinance shall be effective and in full force immediately upon its adoption.

SECTION 6. It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public, and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.
