City Staff

Waterstone has not yet ordered or installed the fountain as we are awaiting power from TNMP and for the stabilization of the pond water level.

However the line item in our budget is 15,000 based on the following:

Pump \$9,000

Electrical Power Install (TNMP) \$4,000

Licensed Electrical Install \$ 600.

Physical Install of Pump in Pond \$1,200.

Mounting Pedestal \$. 200.

Of these the pump is substantiated by the bid below, the TNMP is typical of what is being changed to electrify the community in general.

As the pond excavation and drainage swales created by the increase in height already exceed the cost of the Park Fees and we are will not need to rely on the pump to justify the waiver I trust this information will be sufficient.
