

RESOLUTION NO. 20220913-010

**A RESOLUTION OF THE CITY OF ANGLETON, TEXAS
AUTHORIZING CITY COUNCIL TO CONSIDER
APPOINTMENTS TO FILL VACANCIES AND ABSENCES
ON ALL BOARDS, COMMISSIONS AND COMMITTEES
ANNUALLY IN THE MONTH OF OCTOBER, PROVIDING
FOR REPEAL AND PROVIDING FOR AN EFFECTIVE
DATE.**

WHEREAS, the City of Angleton, Texas City Charter the City has the power to exercise any and all powers conferred by the laws of the State of Texas, and City Council shall appoint commission and committee members;

WHEREAS, no previous ordinance provides for a particular time of year by which a vacancy or absence is to be filled by appointment of the City Council; and

WHEREAS, authorizing city council to appoint members to fill vacancies and absences once a year in the same month provides uniformity, minimizes time spent, and alleviates confusion caused by the absence of language or vague language regarding appointments; and

WHEREAS, the City Council desires to fill vacancies and absences by appointment on all boards, commissions and committees annually in the month of October;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS:

SECTION 1. The facts set out in the preamble are found to be true and correct and are incorporated herein for all purposes.

SECTION 2. The appointments authorized by this resolution apply to the following: Parks and Recreation Board (Code of Ordinances, City of Angleton, Texas—Chapter 17 Parks and Recreation, Art. II Park and Recreation Board, Sec. 17-17 Term of Office); Electrical Board (Code of Ordinances, City of Angleton, Texas—Chapter 5 Buildings and Building Regulations, Art. V Electrical Board, Sec. 5.81 Structure of Board); Charter Review Commission (City of Angleton, Texas Home Rule Charter Angleton, Texas, Art. 10 General Provisions, Sec. 10.10 Charter Review Commission); Mechanical Board (Code of Ordinances, City of Angleton, Texas—Chapter 5 Buildings and Building Regulations, Art. VI Mechanical Code, Sec. 5-181 Creation, appointment, selection); Angleton Better Living Corporation (Articles of Incorporation, Art. 8); Plumbing Appeals and Advisory Board (Code of Ordinances, City of Angleton, Texas—Chapter 5 Buildings and Building Regulations Art. VII Plumbing, Sec. 5-272 Appointment and terms of office); Board of Adjustments (Code of Ordinances, City of Angleton, Texas—Chapter 28 Zoning, Art. II Zoning and Procedures and Administration, Sec. 28-23 Board of Adjustments); Animal Services Advisory Committee (Code of Ordinances, City of Angleton, Texas—Chapter 4 Animals, Art. III Impoundment, Sec. 4-83 Animal services advisory committee members; terms; offices); Keep Angleton Beautiful Commission (Code of Ordinances, City of Angleton, Texas—Chapter 2 Administration, Art. III Boards, Committees, Commissions, Sec. 2-90 Composition; appointment;

terms); and Planning and Zoning Commission (Code of Ordinances, City of Angleton, Texas—Chapter 28 Zoning, Art. II Zoning Procedures and Administration, Sec. 28-22 Planning and zoning commission); as amended.

SECTION 3. City Council shall make all appointments and fill all vacancies on all boards, commissions, and committees once a year in the month of October.

SECTION 4. **Repeal.** All other resolutions or parts of resolutions inconsistent or in conflict herewith are repealed, to the extent of such inconsistency or conflict.

SECTION 5. **Effective date.** This resolution shall be effective and in full force immediately upon its adoption.
