ORDINANCE NO. 20220913-016

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS RATIFYING THE INCREASE OF \$664,405.00 IN PROPERTY TAX REVENUES OVER LAST YEAR'S OPERATING BUDGET AS REFLECTED IN THE FY 2022-2023 OPERATING BUDGET.

WHEREAS, Section 102.007 (c) of the Texas Local Government Code provides that adoption of a budget that will require raising more revenue from property taxes than in the previous year, requires a separate vote of the governing body to ratify the property tax increase reflected in the budget and that a vote under this subsection is in addition to and separate from the vote to adopt or vote to set the tax rate;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS:

SECTION 1. The City Council ratifies an increase in property tax revenues over last year's operating budget as reflected in the FY 2022-2023 Budget in accordance with Section 102.007© of the Texas Local Government Code.

SECTION 2. The meeting at which this Ordinance was approved was a regular meeting of the City Council, and in all things, was conducted in strict compliance with the Texas Open Meetings Act, Texas Government Code, Chapter 551.

SECTION 3. This Ordinance shall become effective immediately upon its passage and approval at a regular meeting of the City Council of the City of Angleton, Texas on this the 13th day of September, 2022, at which meeting a quorum was present and the meeting was held in accordance with the provisions of the Tex. Gov't Code, Section 551.001 *et seq.* The City Secretary is hereby directed to record this Ordinance and the vote to ratify the tax revenue increase with majority vote as follows:
