

**ORDINANCE NO. 20220913-016**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS RATIFYING THE INCREASE OF \$664,405.00 IN PROPERTY TAX REVENUES OVER LAST YEAR'S OPERATING BUDGET AS REFLECTED IN THE FY 2022-2023 OPERATING BUDGET.**

**WHEREAS**, Section 102.007 (c) of the Texas Local Government Code provides that adoption of a budget that will require raising more revenue from property taxes than in the previous year, requires a separate vote of the governing body to ratify the property tax increase reflected in the budget and that a vote under this subsection is in addition to and separate from the vote to adopt or vote to set the tax rate;

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS:**

**SECTION 1.** The City Council ratifies an increase in property tax revenues over last year's operating budget as reflected in the FY 2022-2023 Budget in accordance with Section 102.007© of the Texas Local Government Code.

**SECTION 2.** The meeting at which this Ordinance was approved was a regular meeting of the City Council, and in all things, was conducted in strict compliance with the Texas Open Meetings Act, Texas Government Code, Chapter 551.

**SECTION 3.** This Ordinance shall become effective immediately upon its passage and approval at a regular meeting of the City Council of the City of Angleton, Texas on this the 13th day of September, 2022, at which meeting a quorum was present and the meeting was held in accordance with the provisions of the Tex. Gov't Code, Section 551.001 *et seq.* The City Secretary is hereby directed to record this Ordinance and the vote to ratify the tax revenue increase with majority vote as follows:
