#### ORDINANCE NO. 20220208-008

AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS AMENDING THE GARBAGE AND REFUSE RATE TABLES IN THE FEE SCHEDULE IN THE CONSOLIDATED SCHEDULE OF FEES OF THE CODE OF ORDINANCES OF THE CITY OF ANGLETON, TEXAS, REVISING AND PROVIDING FOR AN INCREASE IN THE RATES TO BE CHARGED FOR SOLID WASTE COLLECTION BY THE CITY OF ANGLETON; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES: PROVIDING  $\mathbf{A}$ **SEVERABILITY** CLAUSE; PROVIDING FOR AN OPEN **MEETINGS CLAUSE**: PROVIDING A PENALTY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** on January 01, 2018, the City Council of the City of Angleton granted to Waste Connections, Inc., a franchise, license and privilege to collect, haul and dispose of municipal solid waste within the corporate limits of the City; and

**WHEREAS**, it is in the best interests of the public health, safety and welfare that this amendment to the garbage and refuse collection rates be effective February 08, 2022;

# NOW THEREFORE, BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS:

**SECTION 1.** The matters and facts recited in the preamble hereof are hereby found and determined to be true and correct.

**SECTION 2.** The Fee Schedule in the consolidated schedule of fees of the Code of Ordinances, City of Angleton, Texas, is hereby amended to reflect all water customers located within the city limits of the City of Angleton, Texas, shall pay the rates for solid waste collection as shown in Exhibit "A".

**SECTION 3.** If any provision, section, sentence, clause or phrase of this Ordinance, or the application of same to any person or set of circumstances is for any reason held to be unconstitutional, void, invalid, or unenforceable, the validity of the remaining portions of this Ordinance or its application to other persons or sets of circumstances shall not be affected thereby, it being the intent of the City Council of the City of Angleton in adopting, and of the Mayor in approving this Ordinance, that no portion hereof or provision or regulation contained herein shall become inoperative or fail by reason of any unconstitutionality or invalidity of any portion, provision or regulation.

**SECTION 4.** All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of said conflict.

**SECTION 5.** The City Council has found and determined that the meeting at which this Ordinance is considered is open to the public and that notice thereof was given in accordance with the

provisions of the Texas Open Meetings Act, Texas Government Code, Chapter 551, as amended, and that a quorum of the City Council was present.

**SECTION 6.** That this Ordinance shall become effective immediately upon its passage and approval, with new rates reflected in the utility bill due in March 2022.
