**RE:** **ADOPT RESOLUTION NO. 25-41, THEREBY APPROVING THE FIVE-YEAR (5-YEAR) PROFESSIONAL SERVICES AGREEMENT FOR ENGINEERING SERVICES WITH LUMOS & ASSOCIATES WITH A TERM BEGINNING DATE OF JULY 2, 2025 THROUGH TERM END DATE OF JUNE 30, 2025**

### **RECOMMENDATION:**

Staff recommends the City Council adopt **Resolution No. 25-41**, thereby approving the five-year (5-year) Professional Services Agreement (PSA) for Engineering Services with Lumos & Associates and authorizing the City Administrator to execute the contract.

### **BACKGROUND:**

The City of Angels periodically requires professional engineering services for various public works, infrastructure, and capital improvement projects. In anticipation of upcoming projects and in alignment with the expiration of the current agreement with Dewberry Engineers Inc. on June 30, 2025, the City initiated a process to secure qualified engineering support on an as-needed basis.

Lumos & Associates was identified as a qualified firm with the experience and capacity to provide general civil engineering services, including planning, design, bidding support, and construction oversight.

### **DISCUSSION:**

Attached for consideration is the City's standard contract for Engineering Services, which was reviewed by the City Attorney. This agreement will allow the City to issue task orders for specific engineering work as needed.

The contract has been signed by the firm and is now presented to Council for formal acceptance. Any future work will be defined under separate task orders, approved either by Council or administratively depending on the scope and cost.

This agreement does not replace the existing contract with Dewberry Engineers Inc., which remains active and may be extended to allow for the completion of open projects.

### **FINANCIAL IMPACT:**

There is no immediate fiscal impact from approving the contract. Costs for engineering services will be incurred on a task-order basis and will be allocated to specific projects within the approved budget.

### **ENVIRONMENTAL CONSIDERATION:**

The above-mentioned action is exempt from California Environmental Quality Act (CEQA) review via CEQA Guidelines 15061(b)(3) since said action is not a “project,” and that the activity does not cause a direct change, indirect change, or significant effect on the environment.
