

RESOLUTION 25-44

APPROVAL OF THE CITY COUNCIL OF THE CITY OF ANGELS TO EXECUTE TASK ORDER NO. 23 WITH DEWBERRY ENGINEERS, INC. IN AN AMOUNT NOT TO EXCEED \$104,000 FOR THE CONSTRUCTION OVERSIGHT AND ENGINEERING SERVICES DURING CONSTRUCTION FOR THE MARK TWAIN WATER DISTRIBUTION SYSTEM IMPROVEMENTS PROJECT

WHEREAS, the existing water distribution system near Mark Twain School is undersized and includes several dead-end lines; and

WHEREAS, low water pressures occur at the higher elevations and maintenance of the dead-end lines is problematic; and

WHEREAS, because of a lack of a completely looped system, if a waterline fails, the number of water services interrupted is significantly higher than if water can be supplied from two directions; and

WHEREAS, under the Mark Twain Water System Improvements Project, dead-end lines will be eliminated on Tuolumne Avenue and Stanislaus Avenue with additional water made available through a new connection to existing waterlines in Mark Twain Road; and

WHEREAS, undersized 4-inch waterlines on Stanislaus Avenue and Oneida Street will be replaced and a new waterline extension constructed on Gold Cliff Road; and

WHEREAS, approximately 2000 feet of new waterlines will be constructed as part of the project; and

WHEREAS, residential services will be re-connected to the new waterlines; and

WHEREAS, the above-mentioned Project was bid on March 11, 2025, and the Project was awarded to Njirich & Sons LLC for the 150 calendar day Project; and

WHEREAS, the Project commenced May 20, 2025, and is scheduled to be completed October 16, 2025; and

WHEREAS, the City has requested assistance from Dewberry Engineers, Inc. (Consultant) in construction oversight of the Project including construction management, inspection, and engineering services during construction; and

WHEREAS, inspection services and materials testing will be furnished by UNICO and Crawford and Associates under contract to Dewberry Engineers, Inc; and

WHEREAS, the approval of Task Order 23 for the above-mentioned project will enable the Consultant and sub-contractors under the Consultant's purview to continue providing the necessary construction oversight and engineering services during construction.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Angels, the City Council approves the City Administrator to execute Task Order No. 23 for the Mark Twain Water Distribution System Improvements Project for the reasons and needs as stipulated within this Resolution; with the Resolution being adopted by the following roll call vote:
