(May 15, 2025) – The Apex Town Council provides notice of a Public Hearing during it's regularly scheduled Town Council Meeting on **Tuesday, May 27, 2024 at 6:00 PM** to receive input on the town's annual operating budget and capital investment plan for fiscal year 2025-2026. This meeting will be held at the Apex Town Hall located at 73 Hunter Street in Apex, North Carolina.

A copy of the proposed Budget is available for public inspection on the Town's website at www.apexnc.org/budget or in the Office of the Town Clerk. The Town Clerk's Office is open Monday through Friday from 8:00 a.m. until 5:00 p.m. The proposed budget is summarized as follows:

The proposed Budget as presented includes an increase of \$.016 in the ad valorem tax rate to \$0.356 per \$100 valuation. There are proposed changes to the electric, water, sewer and solid waste rates.


