That **WHEREAS**, the **COUNTY** and **TOWN** have an existing legal contract specifying services, terms and conditions under which the **COUNTY** provides specified services to the **TOWN**; and,

**WHEREAS**, said contract was officially signed by both parties; and,

**WHEREAS**, said contract specified the compensation to be transferred between the **TOWN** and the **COUNTY**, and the terms of said contract; and,

**WHEREAS**, **TOWN** desires to continue **COUNTY'S** services for an additional period to the current contract; and,

**WHEREAS**, the **COUNTY** has accepted this continuation and is desirous of a continued relationship with the **TOWN** to provide these services.

**NOW, THEREFORE**, and in consideration of the continued services offered by the **COUNTY** and agreed to by the **TOWN**, the **COUNTY** and **TOWN** mutually agree to amend the "TERM" of the contract as it relates to the expiration term to read "6/30/2025" and all references to a completion date on or before June 30, 2023 to read "June 30, 2025." All other rights, terms, and considerations currently contained in this contract remain in effect.
