WHEREAS, the Town Council (the "Town Council") of the Town of Apex, North Carolina (the "Town") adopted an order authorizing \$15,000,000 Street and Sidewalk Improvement Bonds on September 1, 2015, which order was approved by the vote of the majority of the qualified voters of the Town who voted thereon at a referendum duly called and held on November 3, 2015 (the "2015 Bond Order"); and

WHEREAS, the Town Council desires to extend the time period for the issuance of bonds pursuant to the 2015 Bond Order from seven years to ten years after the 2015 Bond Order took effect; and

WHEREAS, Section 159-64 of the General Statutes of North Carolina, as amended, requires the Town Council to conduct a public hearing regarding the proposed extension of the maximum time period for issuing bonds pursuant to the 2015 Bond Order; and

WHEREAS, the Town has applied to the Local Government Commission (the "LGC") for approval of the extension of the 2015 Bond Order;

NOW THEREFORE, BE IT RESOLVED, that the Town Council as follows:

- 1. The Town Council hereby fixes 6:00 p.m. on August 23, 2022, in the Council Chambers of the Town Hall located at 73 Hunter Street in Apex, North Carolina, as the hour, day and place for the public hearing on the proposed extension of the 2015 Bond Order and hereby directs the Town Clerk to publish the 2015 Bond Order once in <u>The News and Observer</u> not later than the 6th day before said date, together with the appended statement as required by G.S. §159-64, as amended.
- 2. The actions of the officers and staff of the Town in applying to the LGC for approval of the extension of the 2015 Bond Order is hereby ratified, approved and confirmed.
