## STATEMENT OF TOWN COUNCIL AND ORDINANCE AMENDING THE OFFICIAL ZONING DISTRICT MAP OF THE TOWN OF APEX TO CHANGE THE ZONING OF APPROXIMATELY 41.02 ACRES LOCATED AT 3228 OLIVE CHAPEL ROAD FROM WAKE COUNTY RESIDENTIAL-80W (R-80W) ZONING TO PLANNED UNIT DEVELOPMENT-CONDITIONAL ZONING (PUD-CZ)

## #24CZ16

**WHEREAS**, Mark Bowles, Baker Residential and Jason Barron, Morningstar Law Group, applicant (the "Applicant"), submitted a completed application for a conditional zoning on the 3rd day of September 2024 (the "Application"). The proposed conditional zoning is designated #24CZ16;

**WHEREAS**, the Planning Director for the Town of Apex, Dianne Khin, caused proper notice to be given (by publication and posting) of a public hearing on #24CZ16 before the Planning Board on the 12<sup>th</sup> day of May 2025;

**WHEREAS**, the Apex Planning Board held a public hearing on the 12<sup>th</sup> day of May 2025, gathered facts, received public comments and formulated a recommendation regarding the application for conditional zoning #24CZ16. A motion was made by the Apex Planning Board to recommend approval; the motion passed by a vote of 7 to 0 for the application for #24CZ16;

**WHEREAS**, pursuant to N.C.G.S. §160D-601 and Sec. 2.2.11.E of the Unified Development Ordinance, the Planning Director caused proper notice to be given (by publication and posting), of a public hearing on #24CZ16 before the Apex Town Council on the 24<sup>th</sup> day of June 2025;

**WHEREAS**, the Apex Town Council held a public hearing on the 24<sup>th</sup> day of June 2025. June Cowles, Senior Planner, presented the Planning Board's recommendation at the public hearing;

**WHEREAS**, all persons who desired to present information relevant to the application for #24CZ16 were allowed to present evidence at the public hearing before the Apex Town Council. No one who wanted to speak was turned away;

**WHEREAS**, the Apex Town Council finds that the approval of the rezoning is not consistent with the 2045 Land Use Map, and other adopted plans in that: the 2045 Land Use Map designates this area Rural Density Residential and approval of this rezoning will automatically amend the 2045 Land Use Map to Low Density Residential north of Olive Chapel Road and Rural Transition Residential south of Olive Chapel Road. This rezoning includes the zoning district Planned Unit Development-Conditional Zoning (PUD-CZ) with a maximum density of 1.6 units per acre (specifically, 1.98 units per acre; north of Olive Chapel Road and 0.246 units per acre; south of Olive Chapel Road). The rezoning to Planned Unit Development-Conditional Zoning (PUD-CZ) will provide the flexibility to accommodate the growth in population and infrastructure consistent with that contemplated by the 2045 Land Use Map.

**WHEREAS**, the Apex Town Council finds that the approval of the rezoning is reasonable and in the public interest in that: the Planned Unit Development-Conditional Zoning (PUD-CZ) rezoning includes the open space preservation with historic structures adjacent to protected open space (south of Olive Chapel Road), preserves 40% RCA, increases vehicle and pedestrian connectivity for the area, and includes three (3) affordable housing units.

**WHEREAS**, the Apex Town Council by a vote of \_\_\_\_\_ to \_\_\_\_ approved Application #24CZ16 rezoning the subject properties located at 3228 Olive Chapel Road from Wake County Residential-80W (R-80W) to Planned Unit Development-Conditional Zoning (PUD-CZ).

## NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF APEX

<u>Section 1</u>: The lands that are the subject of the Ordinance are those certain lands described in Attachment "A" – Legal Description which is incorporated herein by reference, and said lands are hereafter referred to as the "Rezoned Lands."

## Ordinance Amending the Official Zoning District Map #24CZ16

**Section 2:** The Town of Apex Unified Development Ordinance, including the Town of Apex North Carolina Official Zoning District Map which is a part of said Ordinance, is hereby amended by changing the zoning classification of the "Rezoned Lands" from Wake County Residential-80W (R-80W) to Planned Unit Development-Conditional Zoning (PUD-CZ) District, subject to the conditions stated herein.

**Section 3:** The Planning Director is hereby authorized and directed to cause the said Official Zoning District Map for the Town of Apex, North Carolina, to be physically revised and amended to reflect the zoning changes ordained by this Ordinance.

**Section 4:** The "Rezoned Lands" are subject to the conditions in Attachment "B" Lawrence Property PUD which are imposed as part of this rezoning.

**Section 5:** The "Rezoned Lands" shall be perpetually bound to the conditions imposed including the uses authorized, unless subsequently changed or amended as provided for in the Unified Development Ordinance. Site plans for any development to be made pursuant to this amendment to the Official Zoning District Map shall be submitted for site plan approval as provided for in the Unified Development Ordinance.

**Section 6:** This Ordinance shall be in full force and effect from and after its adoption.
