AMENDMENT NO. 2 TO THE ENGINEERING SERVICES AGREEMENT BETWEEN THE TOWN OF APEX AND THE WOOTEN COMPANY DATED July 7, 2020 TWC PROJECT # 2519-CK

The following Amendment shall become a part of the Contract Agreement.

1. SCOPE MODIFICATION:

The scope for Task 2 – Design and Permitting, Item 5, from the original contract has been changed to update the design services for the water main connection from the new elevated storage tank to the distribution system. The original scope included design services based upon a 200 LF distance of 20-inch diameter water main for making the connection from the tank to the distribution system. Due to the selection of the tank site and location of available water mains to connect to the tank, the revision of this task and basis of this amendment is to include design and surveying services for an additional 900+ LF of 20-inch water main along Kings View Trail R/W to connect to the site. In addition, a Subsurface Utility Engineering (SUE) Level A Allowance has been added to locate natural gas mains that cross the Kings View Trail R/W.
