RESOLUTION NO. RES-2026-039 TO INCREASE THE
MEMBERSHIP OF THE PEAK RESILIENCE AND
WELLBEING TASK FORCE

WHEREAS, on April 14, 2026, the Apex Town Council adopted Resolution No. RES-2026-039 establishing the non-standing Peak Resilience and Wellbeing Task Force to promote behavioral health awareness, reduce stigma, support early identification of mental health challenges, improve access to information, resources, and services, and strengthen coordination among local agencies, organizations, and stakeholder; and,

WHEREAS, Resolution No. RES-2026-039 established the Task Force through June 30, 2028, unless its term is extended or the Task Force is subsequently established as a standing advisory body; and,

WHEREAS, Resolution No. RES-2026-039 further provides that the Task Force shall consist of eighteen (18) official members, along with additional volunteers, representing diverse expertise and community perspective; and,

WHEREAS, the Town Council desires to broaden formal participation on the Task Force and provide additional opportunities for representation of diverse professional expertise, lived experiences, and community perspectives; and,

WHEREAS, increasing the number of official members will provide additional capacity for the Task Force to carry out its established purpose and responsibilities while maintaining the existing governance framework and organizational structure.

NOW, THEREFORE BE IT RESOLVED, by the Town Council of the Town of Apex, North Carolina, that Resolution No. 2026-039 is hereby amended as follows:

Section 1: Membership Amendment.

Item No. 2 of the composition and regulations of the Peak Resilience and Wellbeing Task Force is amended to read:

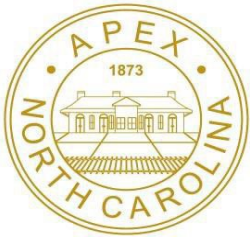
“shall consist of thirty (30) official members and a host of other volunteers, as outlined in Attachment A, representing diverse expertise and community perspectives.”

Section 2. Remaining Provisions Unchanged.

Except as expressly amended herein, all other provisions, responsibilities, authorities, terms, and requirements contained in Resolution No. RES-2026-039 shall remain unchanged and in full force and effect.

Section 3. Effective Date.

This resolution shall become effective immediately upon adoption.
