Have emergency vehicles had a history of problems in trying to access this block of Olive Street described below? Since it's in the grid and there are multiple parking lot access points and ways around that block I'm wondering if parking during peak church times significantly affects emergency response. It may be inconvenient during peak times, but I'd need more justification from PD and FD to pursue this. Please let me know what your departments have experienced out there and if there's good justification for limiting parking to one side based on emergency response. Most of this block is the typical minimum 27' b-b curb standard except the 25% of frontage on the southeast end where we still have grass shoulder

Hey Russ!

I am sending this email on behalf of Apex United Methodist Church to ask if there is a potential to add some no parking signage or line painting on our campus along Olive Street. Our goal is to stop street parking along Olive Street from Elm St to Hughes St on the side of the street that is not on the church side.

We have struggled to find a solution to stop parking on both sides of the street on Sunday mornings as it makes it a tight squeeze to pass and certainly would create a problem for emergency vehicles. Almost two years ago we purchased small no parking sandwich board signs that our team puts out on Sunday mornings. Over time they have been run over, worn out and stolen and we are making this request in the hope of finding a permanent solution with the town.

Our preference is to have the street painted along this whole block on that side of the street to designate no parking. Signs would be our second choice. We own half of the street frontage on this stretch of the block and the other half is a privately owned residence so the street painting would prevent signage installation on their property.

We can help with costs if needed. We are just trying to find a permanent solution to the problem. Let me know if you need additional information from me regarding this request.
