Motion to award a construction contract for 2021 Road Rehabilitation Project (R-21-05), Base Bid and Alternates 1, 2, and 3 to Barnhill Contracting Company, and authorization for the Interim Town Manager to execute the contract on behalf of the Town, and to approve corresponding Capital Project Ordinance Amendment 2021-17

Item Details

The scope of work includes milling and repaving, and includes the streets in the following locations: Salem Woods, Walden Creek/Walden Townes, Hunter Valley, Charleston Village/Sutton Place/Montclair, Justice Heights/Sugarland Run, St James Village, Pearson Farms, Perry Hills/Perry Farms, Brittany Trace, Surrey Meadows, Amherst, Greenbrier/Kelly West, Scotts Mill, Homestead Park, and Dogwood Ridge. Map selection is based on Pavement Condition Index values from the most recent Pavement Condition Survey (conducted in 2020).

Sealed bids for construction and furnishing of all materials were received and opened on Thursday, June 10, 2021. It is the recommendation of staff that the contract for the Base Bid and Alternates 1, 2, and 3 be awarded to Barnhill Contracting Company as the lowest responsive bidder. The total cost estimate of \$5,935,500 includes 10% contingency. Funding for the scope of work includes \$5 million from 2015 transportation bond authorization and the remaining \$935,500 transferred from the FY 2020-2021 department operating budget.
