I was sitting on the floor of my grandparents' house in India when the lights suddenly went out. The ceiling fan spun to a stop, the room went dark, and everything around me went quiet. My phone battery was nearly dead, and I sat idly, waiting. But the electricity didn't come back until the next morning. That experience gave me a glimpse into something I had never truly felt before: disconnection. No light, no signal, no access to the outside world. I felt cut off in every sense. For me, it only lasted a few nights. But for so many people in the communities I come from, this is the daily norm. Even as my laptop screen lights up now, there are students like me who study textbooks under streetlamps and flickering candles. Electricity means more than just charging devices, it's access to education, communication, and opportunity. Without it, people are isolated, left behind while the rest of the world moves forward.

Through my participation in the First Lego League robotics competition and consulting with local energy experts, I learned that there is lots of room for growth in making clean energy accessible to everyone. Renewable energy has great potential but faces many limitations, and most of the energy produced is used inefficiently. With my robotics team, I helped prototype a smart charger designed to reduce energy waste using Arduino and C++. Clean energy matters to me because it allows me to channel my passion into something greater: to give back to the community I come from and help close the gap I've seen firsthand. It was a small project, but it taught me something important: solutions don't have to start big. Innovation can happen anywhere, by anyone. The UN warns that energy efficiency improvement must more than double to ensure universal access to clean energy. This goal is important to me because it emphasizes the large gap between current progress and what needs to happen, and the opportunity for change that exists. I want to be part of the movement to make sure clean energy is accessible for all, especially the communities that I come from, who are too often left behind.

I want to bring this passion, perspective, and problem-solving mindset to the AYC Environmental Advisory Board. As someone who has seen firsthand the inequities caused by lack of energy access, I believe I can bring a unique voice to conversations about sustainability and environmental justice. My experience with the First Lego League Innovation Project taught me how to turn ideas into practical solutions, and serving as a youth voting representative would allow me to represent the concerns and hopes of young people like me who want to be part of building a cleaner, more equitable future.

Being elected as a student leader in 4th and 5th grade, serving as a 7th grade representative in Student Council at my middle school, and serving as a 9th and 10th grade representative in Student Government, I discovered early on my passion for communicating and advocating for student needs. Throughout my time in student government, I've been able to listen to multiple perspectives, collaborate with others, and take action to turn ideas into tangible solutions that benefit the student body. I believe these skills will be valuable on the Environmental Advisory Board, where I can help develop initiatives that address the needs of local youth and bring positive, practical change to the community.

In addition to my leadership background, I bring a strong problem-solving mindset shaped by my experience in the First Lego League Innovation Project.
