

In case you don't have access to the group, I wrote: "Beginning this weekend the GoTriangle Route 305 bus which runs through Apex each hour and continues on to Raleigh has been expanded to run on Saturdays and Sundays. It previously ran on weekdays only. Many here may have never tried it but it's a good way to avoid driving and parking to get to downtown Raleigh and points in between such as Wake Med Cary, Crossroads, the State Fairgrounds and NC State. By using connections to other buses, you can also get to many other destinations in Raleigh, Durham, Chapel Hill etc. Fares are \$2.50 per ride with a max of \$5.00 per day. If you're 65 and over, it's free."

I have worked in the nonprofit sector with grantwriting duties for 40 years, which includes 24 years with Habitat for Humanity. During the past two years, I shifted to packaging together freelance grantwriting assignments and short-term remote part-time work for multiple organizations, such as the Raleigh Area Land Trust, Habitat for Humanity of High Point, and the International Centre for Missing and Exploited Children. My specialties are complex federal applications and highly-competitive national grant programs. In 2024, I had a 100% proposal success rate. Unfortunately, federal politics have eliminated or suspended so many government funding opportunities that my freelance arrangements have shrunk, cancelling proposal assignments that had been calendared through 2027. I am age 62 with a paid-off mortgage and reasonable savings, so I can shift into retirement earlier than expected -- as long as I am extremely frugal. Budget constraints are one reason that I stopped repairing my old car, shifting to the bus for transportation.

I have been a life-long bus rider, and I am currently bus-dependent. During twelve years in Los Angeles, I intentionally lived along 24-hour bus routes with five-minute frequency at my local stop. I did not learn how to drive until moving to Apex at age forty, when there was no bus option for reaching my workplace. But even while owning a car, I would drive into Cary and switch to the bus to reach outlying destinations. Currently, my transportation is approximately 50% by walking, 20% on the GoApex Route One, 20% on the GoTriangle 305, and 10% on the ACX Apex-Cary Express. As a bus rider and pedestrian, I have deep familiarity with the routes, the bus stop locations, sidewalk connections, safety issues, and logistical challenges. Plus, gratitude that Apex now has bus options! I have insight into how other communities handle transit notifications, route changes, on-bus amenities, and covered seating at bus stops. As a regular bus rider, I have conversations with other passengers and have become friendly with many drivers.

During my nonprofit career, I have served low-income populations, advocated for expanded community resources, and highlighted transit access in housing grant proposals. I am a devoted book reader, which includes nonfiction on community development, environmental, and economic issues. I already follow transit and pedestrian advocacy groups on social media.

Please describe three (3) reasons why your service on the chosen board could be beneficial to the Town of Apex.

(1) I can provide the first-hand perspective of a bus rider and pedestrian, supplemented by seeking input from other passengers while on the bus. This includes sharing insight about how the various Triangle bus systems can be better integrated. (2) I am willing to read long documents, research relevant transportation topics, help identify best practices from other communities, and analyze survey data. (3) Given my extensive grantwriting history, I could volunteer to help town staff revise transit grant proposals and grant reports.

If appointed to your preferred board, please describe your top three (3) goals or initiatives you would hope to achieve during your term.

(1) Advancing the plan to add a 2028 bus route that serves the library and parks. I will continue advocating for an interim option - possibly a weekly shuttle -- to help bus riders reach the Eva Perry Library and attend special events, such as Rhythm & Reels at the Apex Nature Park Amphitheatre. (2) Improving communication with bus riders through information posted at bus stops and on the bus itself. For example, the GoApex bus should have a plexiglass rack with printed bus routes for the three transit options that serve the town. (3) Improving bus stops as funding allows, which includes providing covered benches as protection from the weather and improving bus-sidewalk connections. I will advocate for passenger restroom access at the proposed mobility hub.

Most of my volunteer work has been providing virtual grantwriting assistance and fundraising guidance for organizations elsewhere in North Carolina and beyond. For example, I donated proposal development services to help Asheville Area Habitat for Humanity secure \$80,000 for facility restoration after flooding caused by Hurricane Helene. My volunteer work has included training and mentoring, such as delivering a complimentary webinar on Donor Advised Funds for Habitat for Humanity of Alabama. During this summer, as I have shifted into retirement mode, I have become more active locally, which includes attending senior center events, participating in the town's excellent CommUniversity workshops, and offering public comments during town meetings. I have also increased my involvement with political groups and attended rallies in the Triangle. I am currently investigating local volunteer opportunities that are the best match for my skills and reasonably accessible by bus.





My qualifications combine civic engagement, leadership, and research-driven problem solving:

Civic Engagement & Community Representation: As a member of the Apex Youth Council (2025–Present), I help plan and execute community projects, volunteer events, and local outreach initiatives. I collaborate with town staff and peers to ensure that programs reflect the community's needs, including logistics for volunteer cleanups, cultural events, and public forums.

Leadership & Project Management: I founded and led an Odyssey of the Mind team that reached the World Finals three years in a row, managing sponsorships, budgets over \$11,000, and coordinating travel and event planning. This experience taught me how to lead complex projects, resolve conflicts, and make strategic decisions — skills directly transferable to serving on a board that reviews development and policy proposals.

Research & Analytical Skills: Through Duke Pre-College Neuroscience and STEM research projects — including a Python-based project monitoring structural health of bridges — I have developed skills in analyzing data, designing experiments, and presenting actionable insights. These experiences give me the ability to approach town planning, sustainability, and

transportation proposals with evidence-based reasoning.

Volunteerism & Local Impact: I have contributed over 100 volunteer hours to Apex and the surrounding community, including Adopt-A-Highway cleanups, Durham Food Bank service, and large-scale cultural events such as Holi, Dhoom Dham Dhawat, and Bathukamma (2,000+ attendees). I also mentored middle school students in STEM, tutored peers in math, and helped coordinate community service projects — all of which strengthened local engagement and helped make Apex a cleaner, safer, and more connected community.

Civic Leadership Beyond the Board: As an active member of Rhizome, I worked on youth civic campaigns and initiatives to encourage participation in local governance, helping residents understand how their voices can shape town decisions. These experiences have given me perspective on bringing together diverse viewpoints and building programs that have tangible impact for Apex.

Together, these experiences give me the communication skills, problem-solving mindset, and long-term perspective needed to represent youth voices and help shape Apex's future in a thoughtful and balanced way.

As a student who thrives on listening, learning, and leading, I believe the voices of youth hold the power to inspire real, meaningful change — especially in shaping the community we will inherit. Serving on these boards would allow me to be that bridge between students and town leadership.

In Apex, our student population is incredibly diverse in culture, language, and experience — yet many of those perspectives are missing when development proposals are reviewed, environmental policies are discussed, or transportation plans are created. Some of the most important voices are not the loudest — they are the ones we don't hear because they don't yet feel invited to the table. Whether it's a student who feels unsafe biking to school, someone who wishes their neighborhood had more green space, or a classmate who cares deeply about sustainability but doesn't know how to act, their ideas matter.

I know what it feels like to be quiet and hesitant to share opinions — I used to be that student. Over time, I learned that change starts with speaking up, leading projects, and creating space for others to be heard. If selected, I will make it my mission to amplify these unheard voices and bring them into the conversation.

If selected for the Planning Board, I will advocate for youth-friendly, walkable neighborhoods and spaces where students can feel safe and connected.

If selected for the Environmental Advisory Board, I will champion sustainability education, green initiatives, and programs that empower students to take action on climate issues that affect their future.

If selected for the Multimodal Transportation Advisory Board, I will bring forward real student concerns about crossing safety, bike access, and equitable transportation options so youth can get around Apex independently and safely.
