PROJECT SUMMARY:

The Miller's Ale House – Major Development Plan (MDP) proposes a restaurant use with 7,202 square feet of area in the MU-D (Mixed-Use – Downtown) zoning district. As part of the executed Development Agreement for City Center, of which this property is part, the project is not subject to City Council approval. However, the applicant has chosen to undergo the MDP public hearing process to introduce the intent of restaurant use on the subject property, based on public interest. The applicant will address all applicable Code standards at the Construction Site Plan review process.

ACCESS/TRANSPORTATION:

This project will have access via McGee Avenue and cross access with the previously approved Winn Dixie Supermarket site to the east, which has approved access points on Monroe Avenue and U.S. 441.
