**SUBJECT:**

Piggyback Contract: Axon Enterprise, Inc. contract #010720-AXN for body cameras, tasers, and interview room cameras.

**REQUEST:**

Authorize the use of Axon Enterprise, Inc. contract per the assigned terms and include the additional purchase of fifteen evidence.com licenses at a total cost of \$5,517.30 per year for the remaining four years of the contract. This addition would increase the contract cost \$22,069.20, changing the original contract cost from \$1,370,882.75 to \$1,392,951.95.

In May of 2022, the Apopka Police Department entered into a five-year agreement with Axon Enterprise, Inc. for the purchase of new body cameras, tasers, interview room cameras, evidence.com storage and software. The contract includes additional features, equipment, accessories, such as Evidence.com, which stores the audio and video recordings from the body worn cameras and interview rooms. Axon Enterprise, Inc. is currently providing the Police Department with four free limited use licenses. Evidence.com allows for the viewing, redaction and sharing of video recordings for the officers, fulfilling public records requests as well as court cases. With the implementation of the Axon suite of products, the Apopka Police Department has changed some business practices to allow for some civilian personnel to access evidence.com in order to assist with public records requests and State Attorney taskings. Additionally, the body worn camera program was expanded to provide body cameras for our Crime Scene Investigators. In order for the civilian personnel to access evidence.com, the Police Department has to have a license for the use of the software. Although Axon Enterprise, Inc. is providing the Police Department with the four free limited use licenses, to accommodate the needs of the agency an additional fifteen full access licenses are required.

The cost of the evidence.com pro licenses will increase the contract cost to add an approximate \$5,517.30 per year for the remaining four years of the contract. This addition would increase the contract cost \$22,069.20, changing the original contract cost from \$1,370,882.75 to \$1,392,951.95.

**FUNDING SOURCE:**

For the remainder of FY22/23 the funding will come from budget savings. The remaining years will be incorporated into each FY budget.

**RECOMMENDED ACTION:**

Authorize the use of the Axon Enterprise, Inc. contract for the remaining assigned terms and within each fiscal year budgetary appropriations. Authorize the increase to the cost of the contract to include the purchase of an additional fifteen evidence.com licenses at \$5,517.30 per year for the remaining four years of the contract. This addition would increase the contract cost \$22,069.20, changing the original contract cost from \$1,370,882.75 to \$1,392,951.95.
