Special Call Council Meeting
December 17, 2024

The Appomattox Town Council held a Special Call Council meeting on Tuesday December 17, 2024, at 5:35 p.m. at the Appomattox Municipal Building, 210 Linden Street, Appomattox, Virginia with Mayor Conner, presiding.

Members present: James J. Boyce, Sr., Mary Lou Spiggle, Timothy W. Garrett, Claudia G. Puckette, and Nathan Simpson

Mayor Conner called the Special Call meeting to order.

Jane Allen stepped in 5:38 p.m.

Public Appearance: Johnathan Garrett, Appomattox County Volunteer Fire Chief

Mr. Garrett presented information in reference to a 2014 Pierce Arrow XT 75' Aerial Truck. Mr. Garrett requested the support of the Town of Appomattox with purchasing the Fire Truck.

On a motion by Mrs. Puckette, seconded by Mr. Boyce, the Council voted to allow \$300,000 of ARPA funds to be used toward the purchase of the 2014 Pierce Arrow XT 75' Aerial Truck for the Appomattox County Volunteer Fire Station. Mr. Garrett abstained from voting.

ROLL CALL VOTE: Allen-yes, Boyce-yes, Puckette-yes, Simpson-yes, Spiggle-yes. Motion carried 5-0.

An open discussion of items needed was discussed and the following motion was made.

On a Motion by Mr. Boyce and seconded by Mrs. Puckette, the Council voted to allow the use of ARPA funds to purchase the following:

\$100,000 Playground equipment for the Appomattox Kiddie Park

\$100,000 Well Research

\$65,000 AI workstations (two) Mr. Simpson stated that they meet ARPA requirements.

\$300,000 toward Fire Truck for the Appomattox Volunteer Fire Department

\$32679 Camera system for the TOA facilities
