I would like to express my interest in the vacant seat on the board of the Big Plains Water Special Service District. I feel I would be a great addition to the BPWSSD and bring value to the board.

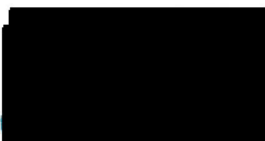
