DISCUSSION AND POSSIBLE ACTION ITEMS

1. **DISCUSSION AND POSSIBLE ACTION ON PRELIMINARY PLAT APPLICATION FOR LOT AV-1-3-5-211 from Heber Allred as owner.**

Mayor Beddo gave a brief overview of the proposal and said the primary issue is water. The project has good water rights and will bring storage and water lines. There will be onsite sewer and no septic. The conclusion was that staff is good with moving forward with the commission making a positive recommendation to the council. The project has met utility demands. Allen Angell asks how does the town get the project owners committed to this plan; Mayor Beddo says that is done through the final plat process and bonding. Project features such as commercial, tourist commercial and residential were addressed. Access was discussed.

Motion made by Janet (18') to approve the preliminary plat application and send forward to the town council; Lee second. No further discussion, vote all ayes.

2. **DISCUSSION WITH NO ACTION ON AMENDING THE GENERAL PLAN RELATING TO THE TOURIST COMMERCIAL DESIGNATION. PROPOSED CHANGES WOULD MAKE THE GENERAL PLAN DESIGNATION FOR TOURIST COMMERCIAL EXTEND ONLY 1/2 A MILE FROM THE MAINSTREET AND SR-59 INTERSECTION INSTEAD OF 1 MILE.**

Allen Angell suggests action could be taken due to a hearing being held in a previous Planning Commission meeting. The commission talked about possible changes that could be made to the south of the intersection; how access to the highways would look; and what effect changes would have for development. Richard Fischer made a motion (34') to recommend to the council that we amend the Tourist Commercial areas on the General Plan map to extend one half mile along the southern portions of the highways from their intersection. Lee second. No further discussion, all vote aye.

4. **DISCUSSION WITH NO ACTION ON ZONE CHANGE APPLICATION FOR AV-1311-U**

Mr. Wilson of AV-1311-U is invited to discuss a project for the parcel. No zoning sought now, only input from town as to what zoning might be best. Some discussion of AG zoning versus residential.
