- 3. There was one addition and no deletions to the agenda. City Manager Frazer spoke to add New Business Item No. 3, under the City Manager Department, Motion to apply for a 2023 Trails Application to CDBG.

Motion made by Commissioner Rogers, Seconded by Commissioner Warren to approve the addition to agenda as presented.

Approval of the Agenda

Motion made by Commissioner Jennings, Seconded by Commissioner Gingher to approve the agenda as presented.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared motion approved.

1. Recognize the City of Arkansas City and Jennifer Waggoner/Finance Department as recipient of the GFOA's Distinguished Budget Presentation Award, Special Performance Measures Recognition, and Strategic Goals & Strategies Recognition.

City Manager Frazer presented Waggoner with two of the framed awards. Mayor Spielman shook Waggoners hand congratulating her for all her hard work, while the audience gave a liking applause for such an honorable achievement.

1. Approve the February 21, 2023, regular meeting minutes and the February 22, 2023 special meeting minutes as written

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared motion approved.

New Business

City Manager Department

1. Deputy City Clerk Parsons presented that The City of Arkansas City will hold a public meeting for the purpose of evaluation the performance of the Grant No. 12-PF-002 for the purpose of street improvements consisting of milling and overlay of Summit Street from Kansas Ave. to Radio Lane.

Mayor Spielman moved to open the public meeting. Commissioner Rogers seconded.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared motion the approved.

Municipal Consultant Rose Mary Saunders, with Ranson Financial Group LLC, addressed the commission with the purpose of holding the grant evaluation performance public meeting. Saunders also spoke of the request to close out the grant.

Mayor Spielman called for a motion to close the public meeting. Commission Warren moved and Commissioner Rogers seconded.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared the motion approved.

2. Deputy City Clerk Parsons announced the authorization of Mayor, or Mayor's, to sign the appropriate documentation to close out Community Development Block Grant (CDBG) No. 21-PF-002.

Motion made by Commissioner Gingher, Seconded by Commissioner Warren to approve the item as written.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared the motion approved.

Deputy City Clerk Parsons presented the Motion to apply for a 2023 Trails Application to CDBG.

Consultant Saunders discussed that the city received a Sunflowers Trails Foundation Grant for \$50,000.00 and one of the new categories, with a May 1st deadline for CDBG, is sidewalks and trails. This proposal includes the trails between the Paris Park Swimming Pool, North to Northwest Center, and the Lovie Watson Park Area.

Motion made by Commissioner Warren, Seconded by Commissioner Rogers to approve the item as written.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared the motion approved.

With approval of the grant application, Consultant Saunders mentioned a public hearing to be held at the first meeting in April.

4. Deputy City Clerk Parsons presented a Resolution authorizing the City of Arkansas City to approve a bid submitted by New Windows For America, to install vinyl siding, a new roof, a new storm door (front & back), new guttering, build a new cellar door, new windows, install a new guardrail, install a radon mitigation system, and secure electrical at 1209 W. Oklahoma, for an amount not to exceed \$40,000.

City Manager Frazer discussed details of the item.

Motion made by Commissioner Rogers, Seconded by Commissioner Warren to approve the item as written.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared the motion approved.

5. Deputy City Clerk Parsons presented a Resolution authorizing the City of Arkansas City to approve a bid submitted by Arambula Construction Company, to install vinyl siding, a new storm door (front & back), new guttering, new windows, and secure electrical at 1328 W. Oklahoma, for an amount not to exceed \$20,123.

City Manager Frazer discussed details of the item.

Motion made by Commissioner Gingher, Seconded by Commissioner Warren to approve the item as written.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared the motion approved.

6. Deputy City Clerk Parsons presented that the commission consider a Resolution authorizing the City of Arkansas City to approve a bid submitted by New Windows For America, LLC to install vinyl siding, a new roof, new guttering, new windows, install a new guardrail, and secure electrical at 1417 N. 10th, for an amount not to exceed \$25,000.

Motion made by Commissioner Warren, Seconded by Commissioner Gingher to approve the item as written.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman declared the motion approved.

7. Deputy City Clerk Parsons presented a Resolution authorizing the City of Arkansas City to approve a bid submitted by New Windows For America, LLC to install vinyl siding, new storm door (front & back), new guttering, new windows, install a new guardrail, and secure electrical at 1422 W. Oklahoma, for an amount not to exceed \$26,050.

City Manager Frazer discussed details of the item.

Motion made by Commissioner Rogers, Seconded by Commissioner Gingher to approve the item as written.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman declared the motion approved.

8. Deputy City Clerk Parsons presented a Resolution authorizing the City of Arkansas City to approve a bid submitted by Arambula Construction Company, to install vinyl siding, new storm door (front & back), new guttering, new window, and secure electrical at 1507 N. 10th, for an amount not to exceed \$21,276.

City Manager Frazer discussed details of the item. Commissioner Warren questioned if these property approvals tonight used all the allotted grant dollars. Frazer confirmed that these were all part of the approved CDBG dollars and there is still more homes and grant funds left. Commissioner Jennings confirmed that Principal Planner White was the contact for grant applications.

Motion made by Commissioner Jennings, Seconded by Commissioner Gingher to approve the item as written.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared the motion approved.

9. Deputy City Clerk Parsons presented an Ordinance adopting the 2022 Comprehensive Plan and Future Land Use Maps for the City of Arkansas City, Kansas; incorporating such plan and maps by reference pursuant to K.S.A. 12-741 et seq., K.S.A. 12-3009:3012 and K.S.A. 12-3301:3302.

Principal Planner White presented a brief explanation of the 2022 Comprehensive Plan and Future Land Use Maps to the commission. The Commission commended White and staff for their work put forth in making the comprehensive plan full of information that is historical and easy to read.

Motion made by Commissioner Warren, Seconded by Commissioner Gingher to table the item to the next meeting.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared the motion approved.

10. Deputy City Clerk Parsons presented a Resolution Authorizing the City of Arkansas City to purchase a 2023 Ferrara Heavy-Duty Engine Tanker with a Hale QMax 2,000 GPM Pump, and a 3,000 Gallon Booster Tank from Fire Master Equipment, Inc., of Springfield Missouri, for an amount not to exceed \$888,400.00.

Interim Fire/EMS Chief Cassaboom gave an update on mechanical repair issues with various trucks including the current T-Engine. Chief Cassaboom and Engineer/EMT McClure presented details of the proposed T-Engine.

Motion made by Commissioner Warren, Seconded by Commissioner Gingher to approve the item as written.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared the motion approved.

11. Deputy City Clerk Parsons announced the next item to explain the Kansas Law Enforcement Accreditation Program (KLEAP) the police department is undertaking for the next 2 years.

Police Chief Burr gave a brief explanation of the KLEAP program and future benefits to the department. Burr is currently working towards becoming an assessor for the KLEAP program. Lieutenant Legleiter gave a PowerPoint presentation further explaining the program in more detail. Staff concluded that KLEAP will be a tremendous asset to the department, most cost-effective, and holds a higher standard specific to Kansas as compared to the currently used program.

12. Deputy City Clerk Parsons introduced a resolution authorizing an annual Government Rental Agreement with PrairieLand Partners, LLC of Winfield, KS to rent a 6M/R John Deere Tractor, for an 8-month/300-hour term, for an amount not to exceed \$7,950 per year.

Public Services Superintendent Tapia shared his reasoning behind this request driven by equipment quality and budget. Surrounding townships use this equipment and have had success with both the product and similar agreement set-ups.

Motion made by Commissioner Warren, Seconded by Commissioner Gingher to approve the item as written.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared the motion approved.

13. Deputy City Clerk Parsons presented a Resolution authorizing the purchase of a Land Pride RCM5715 Rotary Cutter - 1000 PTO from Wichita Tractor Company, for an amount not to exceed \$29,100.00.

Motion made by Commissioner Gingher, Seconded by Commissioner Warren to approve the item as written.

Commissioner Jennings questioned and Tapia confirmed that the batwing will be an outright purchase and was the best-found price.

Voting Yea: Commissioner Gingher, Commissioner Jennings, Commissioner Rogers, Commissioner Warren, Mayor Spielman. Mayor Spielman declared the motion approved.

Items for Discussion by City Commissioners

Commissioner Warren inquired about the side-by-side utility vehicle ordinance discussion. Chief Burr stated that it will that place at the next committee meeting.

Commissioner Jennings raised concern for Cox Communications service maintenance calls and the amount being charged to the customer. City Manager Frazier has reached out to Cox, and his pending return responses.

Commissioner Jennings raised concern for the new Creekstone Daycare being built and the safety of children being so close to the Creekstone facility and the surrounding industrial environment.
