A RESOLUTION AUTHORIZING THE CITY OF ARKANSAS CITY TO ACCEPT A BID SUBMITTED BY MIDCO DIVING & MARINE SERVICES, INC. TO CONDUCT WATER TANK CLEANING AND INSPECTIONS, FOR AN AMOUNT TO EXCEED \$18,924.00.

WHEREAS, The City of Arkansas City is required by the Kansas Department of Health and Environment (KDHE) to clean and inspect all potable water storage tanks every 3-5 years; and

WHEREAS, in order to comply with KDHE regulations and prevent the need to drain water tanks, the Environmental Services Department recommends using professional diving services that perform inspections and cleanings while the tanks remain in service. This method conserves water, minimizes downtime, and maintains regulatory compliance; and

WHEREAS, the base cost for the cleaning and inspections is \$18,924.00, with any additional sediment removal exceeding three inches and any necessary epoxy repairs billed at \$480.00 per hour, to be authorized and submitted through change orders.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF ARKANSAS CITY, KANSAS:

SECTION ONE: The Governing Body of the City of Arkansas City, Kansas, hereby authorizes the City of Arkansas City, Kansas, to accept a bid submitted by Ingersoll Rand, to accept a bid submitted by Midco Diving & Marine Services, Inc. to conduct water tank cleaning and inspections, for an amount to exceed \$18,924.00.

SECTION TWO: The Governing Body of the City of Arkansas City, Kansas, hereby authorizes the Mayor and/or City Staff of The City of City of Arkansas City, Kansas, to take such further and other necessary actions that are required to effectuate the intent and purposes of this Legislative Enactment.

SECTION THREE: This Resolution shall be in full force and effect from its date of passage by the Governing Body of the City of Arkansas City, Kansas.
