Ordinances for Consideration

 City Clerk Shook presented for consideration first reading of an Ordinance adopting by reference the Standard Traffic Ordinance for Kansas Cities, 49th Edition, prepared and published in book form in 2022 by the League of Kansas Municipalities. City Attorney Schwartz discussed the substantive changes with the commission.

Motion made by Commissioner Warren, Seconded by Commissioner Jennings to approve the Ordinance adopting by reference the Standard Traffic Ordinance for Kansas Cities, 49th Edition, prepared and published in book form in 2022 by the League of Kansas Municipalities.

 City Clerk Shook presented for consideration first reading of an Ordinance adopting by reference the Uniform Public Offense Code for Kansas Cities, 38th Edition, prepared and published in book form in 2022 by the League of Kansas Municipalities. City Attorney Schwartz discussed the substantive changes with the commission.

Motion made by Commissioner Warren, Seconded by Commissioner Jennings to approve the Ordinance adopting by reference the Uniform Public Offense Code for Kansas Cities, 38th Edition, prepared and published in book form in 2022 by the League of Kansas Municipalities.

3. City Clerk Shook presented for consideration first reading of an Ordinance amending Zoning Regulations Article 28 (Floodplain Management), and incorporating such regulations by reference. Principle Planner White noted this is a community rating system and only involves cases of new construction or major improvement. The planning commission has recommended all the changes be approved.

Motion made by Commissioner Spielman, Seconded by Commissioner Jennings to approve the Ordinance amending Zoning Regulations Article 28 (Floodplain Management), and incorporating such regulations by reference.

Roll Call Voting Yea: Commissioner Jennings, Commissioner Rogers, Commissioner Spielman, Commissioner Warren, Mayor Gingher. Mayor Gingher declared the motion approved and given <u>Ordinance No. 2022-09-4562</u>.

4. City Clerk Shook presented for consideration first reading of an Ordinance exempting the application of K.S.A. § 41-719(c) to allow the sale and consumption of alcoholic liquor at a designated area of Wilson Park during Cowley Market Craft Show, from 10:00 a.m. to 4:00 p.m. on Saturday, September 24, 2022. Shelley Robertson, One Margarita Express LLC, addressed the governing body to allow her to sell and serve alcohol at a designated area of Wilson Park during the Cowley Market Craft Show. She stated she will take all necessary precautions to ensure the property is used in full compliance with applicable state and local law.

Motion made by Commissioner Warren, Seconded by Commissioner Spielman to approve the Ordinance exempting the application of K.S.A. § 41-719(c) to allow the sale and consumption of alcoholic liquor at a designated area of Wilson Park during Cowley Market Craft Show, from 10:00 a.m. to 4:00 p.m. on Saturday, September 24, 2022.

Roll Call Voting Yea: Commissioner Rogers, Commissioner Spielman, Commissioner Warren, Mayor Gingher. Voting Nay: Commissioner Jennings. Mayor Gingher declared the motion approved and given **Ordinance No. 2022-09-4563.**

Motion made by Commissioner Warren, Seconded by Commissioner Rogers to also waive the age restriction at the Agri-Business building during the 3 other Cowley Market Events scheduled on October 8, 2022, November 19, 2022, and December 3, 2022 as long as the area is fenced and monitored.

Voting Yea: Commissioner Rogers, Commissioner Spielman, Commissioner Warren, Mayor Gingher. Voting Nay: Commissioner Jennings. Mayor Gingher declared the motion approved.

Resolutions for Consideration

1. City Clerk Shook presented for consideration a Resolution regarding the cleanup of the property located at 425 W Quincy Avenue, Arkansas City, Kansas, and providing for cooperation with the Kansas Department of Health and Environment in achieving said repair and cleanup. Toby Kuhn/Kansas Department of Health Environmental compliance/regulatory specialist was available to answer any questions the commission had. It was noted that the owners of the property have approved a "consent to access" agreement.

Motion made by Commissioner Warren, Seconded by Commissioner Rogers to approve the Resolution regarding the cleanup of the property located at 425 W Quincy Avenue, Arkansas City, Kansas, and providing for cooperation with the Kansas Department of Health and Environment in achieving said repair and cleanup.

Voting Yea: Commissioner Jennings, Commissioner Rogers, Commissioner Spielman, Commissioner Warren, Mayor Gingher. Mayor Gingher declared the motion approved and given **Resolution No. 2022-09-3500**.

2. City Clerk Shook presented for consideration the Resolution authorizing the transfer of certain real estate at 212 N 3rd Street to George and Nisa Cummings. Principle Planner stated George and Nisa Cummings own the property to the South and would like to purchase the property to put a garage on it. George Cummings addressed the commission and asked for a reduction in price.

Motion made by Commissioner Warren, Seconded by Commissioner Spielman to approve the Resolution authorizing the transfer of certain real estate at 212 N 3rd Street to George and Nisa Cummings in the amount of \$1.00.

Voting Yea: Commissioner Jennings, Commissioner Rogers, Commissioner Spielman, Commissioner Warren, Mayor Gingher. Mayor Gingher declared the motion approved and given **Resolution No. 2022-09-3501**.

3. City Clerk Shook presented for consideration a Resolution authoring the City of Arkansas to enter into a Memorandum of Understanding with "a to be determined entity" composed of Consolidate Housing Services and Consolidated Development Partners, to acquire property and develop a residential housing development on the city owned lot bordered by N. 1st Street, N. 2nd Street, W. Birch Avenue, and W. Pine Avenue.

Motion by Commissioner Spielman to table until next meeting. The motion died for a lack of second.

John Sybrant addressed the commission regarding this item.

Motion by Commissioner Jennings, Seconded by Commissioner Rogers to table for a future agenda item.

Voting Yea: Commissioner Jennings, Commissioner Rogers, Commissioner Spielman, Commissioner Warren, Mayor Gingher. Mayor Gingher declared the motion approved.

Other Items for Consideration

City Clerk Shook presented for consideration a motion authorizing the City of Arkansas City Commissioners
to sign a letter concerning the 2023 Final IPPS Rule that could cause negative financial consequences to SCK
Health. City Manager Frazer noted that SCK Health CEO, Jeff Bowman, requested this letter to be sent to
our congressman and Senator.

Motion made by Commissioner Warren, Seconded by Commissioner Spielman to authorizing the City of Arkansas City Commissioners to sign a letter concerning the 2023 Final IPPS Rule that could cause negative financial consequences to SCK Health.

Voting Yea: Commissioner Jennings, Commissioner Rogers, Commissioner Spielman, Commissioner Warren, Mayor Gingher. Mayor Gingher declared the motion approved.
