## FANG ACTIVITY REPORT MAY 2025

**05/05-** FANG detectives utilized a confidential informant to conduct a controlled purchase of cocaine from a dealer in the Flint area. The investigation is ongoing.

**05/06** – FANG detectives utilized a confidential informant to conduct a controlled purchase of crack cocaine from a dealer in the Flint area. The investigation is ongoing.

**05/07**– FANG detectives utilized a confidential informant to conduct a controlled purchase of fentanyl from a dealer in the Flint area. The investigation is ongoing.

FANG detectives utilized a confidential informant to conduct a controlled purchase of crack cocaine from a dealer in the Flint area. The investigation is ongoing.

FANG assisted ATF with the execution of a search warrant at the residence of a narcotics dealer in the flint area. As a result, FANG seized 3 firearms and approximately 200 grams of cocaine.

**05/08** – FANG detectives arranged to buy fentanyl from a dealer in the Flint area. A meet spot was established and when the dealer was enroute to the meet spot a traffic stop was conducted. As a result, FANG detectives seized 23 grams of fentanyl and \$351.

Also on this date, FANG detectives along with the ATF agents conducted a search warrant at the residence of a narcotics dealer in the flint area. As a result, FANG detectives seized 15 grams of crack cocaine and approximately 200 grams of fentanyl.

**05/09-** FANG detectives executed a search warrant at the residence of a suspected narcotics dealer. FANG detectives seized 39 grams of crack cocaine and 17 oxycodone pills.

**05/12-** FANG detectives utilized confidential informants to conduct 2 separate purchases of narcotics. The first purchase was for cocaine and the second buy was for crystal meth. Both dealers were identified, and the investigations are ongoing.

**05/13** – FANG detectives assisted Fenton PD with the execution of a search warrant in which 2 firearms were seized.

**05/14-** After several controlled purchases of cocaine from a suspect at an address in Montrose Twp., FANG detectives, with the assistance of the ES team, conducted a search warrant at the residence. FANG detectives seized 1 gram of cocaine and 5 firearms.

**05/15** – FANG detectives utilized a confidential informant to conduct a controlled purchase of cocaine from a dealer in the Flint area. The investigation is ongoing.

Several FANG detectives participated in a multi-agency detail focused on drugs, guns and other criminal activity in the Flint area.

**05/20-** FANG detectives utilized a confidential informant to conduct a controlled purchase of crack cocaine from a dealer in the Flint area. The dealer was identified, and the investigation is ongoing.

**05/27-** FANG detectives utilized a confidential informant to conduct a controlled purchase of crack cocaine from a dealer in the Flint area. The investigation is ongoing.

**05/28-** FANG detectives utilized confidential informants to conduct 3 separate controlled purchases of narcotics. Crack cocaine, fentanyl and cocaine were purchased, and all 3 investigations are ongoing.
