


#### ADDENDUM SCOPE

The following scope-of-service summarizes our strategic approach to successfully complete this project, including scanning the remaining areas in both cemeteries that were not able to be scanned on the initial project visit, due to vegetation / debris. This addendum also includes updating the existing maps with the new scanning results. These areas are shown on the figures below, shaded in pink.

## Scope-of-Service

## Task 1:GPR Survey and Mapping

TriMedia will use the existing cemetery drawing to establish a survey grid. The grid will be used to set up GPR survey paths traversing the plots already established at the property along with other areas of interest. GPR survey will be performed using a GSSI Utility Scan DF, which is equipped with dual frequency (300/800 MHz) antennae, to traverse the cemetery and identify which plots may have been used and which may be empty. Locations of anomalies will be surveyed using GPS equipment. Using the GPR and GPS survey data, TriMedia will provide Atlas Township with an updated digital map depicting the anomalies indicating potential unmarked burials.

## Task 2:GIS Public Access Website

TriMedia will add the new GPR data to the existing website map and make the map open for viewing by the public.

#### ADDENDUM COST & AUTHORIZATION TO PROCEED

In an effort to provide you with a reasonable means of estimating expenses for the project, TriMedia proposes to complete the aforementioned tasks on a time and expense basis for the not-to-exceed cost of **\$3,500.00**. In no case will the estimate be exceeded unless authorized by you in writing.
