NEW BUSINESS

13. Approve the draft RFP for the police pole barn at the Township Hall.

Busch gave overview - The Township is ready to expand the police barn. Need a large building to store the additional police car for our swing deputy. Looking to fix the current barn for Township storage. Recommended to add motion lights inside, justify what type of siding and roofing, and security cameras.

Motion to approve the Supervisor to move forward on the RFP for the police pole barn at the Township Hall with the additions type of material, motion sensor interior lights, and security cameras.

14. Request a process for the disposal on outdated computer equipment.

The Supervisor found a company that will take the old computers. Requesting board support to wipe the hard drives and take them to Save-IT Technologies LLC with no cost to deliver.

For the record, the board supported the decision to wipe the outdated computers and to retain the serial numbers of which computers that are being retired.

15. Consider quote from Breezy Lawn Care to maintain the landscape at the Township Hall and add services to the current contract with a 3 year extension.

The board went over a couple quotes that were obtained. The board agreed the landscaping needed some care and more attention. The board did not feel it necessary to extend the contract at this time.

Motion to approve Breezy Lawn Care quote of \$900.00 to trim shrubs, lay mulch and fertilize the Township Hall for 2025.

16. Discuss TriMedia Environmental to complete work at the Atlas Cemetery.

There was a large section in the Atlas Cemetery that needed to be cleaned out of leaves and brush that is now open. The Supervisor is looking for support to pursue a quote from TriMedia Environmental to complete the mapping and website for Atlas and Horton Cemetery.

17. Vacant Township Lot

Butcher has been inquiring residents on what they would enjoy to see on a piece of vacant property. The conversation was broad from a community garden, park, farmers market, etc.

18. Atlas Township awarded the Par Plan Grant for \$2,500.

The grant was applied to install security cameras around the Township Hall for safety. The Supervisor would like to know if the board would like to continue and accept the grant award. The board is thrilled and would like to proceed with P.A.L. alarms quote for security cameras to fulfill the grant money.

BOARD COMMENTS

Yaklin - Atlas successfully had the May 6 Special Election for Grand Blanc and Davison Schools, there was a low voter turnout. Would like to thank our residents who participated.

Butcher - Started draft job descriptions, would like the board consent to pursue employees for lists of task they preform. Reviewing the Township policies to ensure all are updated.

Moore - The cash counter the Treasurers department was difficult to use, would like on record gifting the cash counter to the Village of Goodrich for their tax collection.

Major - Would like an update on Hegel rd. due to vehicles there.

Busch - The company came for the library awning to repair, when removing the tarp they noticed damaged to the structure. The cost will now be over the original quote, waiting on the additional cost amount. The Township had the annual audit on May 15, went well. 941 report needs amending and the SAD deficient elimination plan has about 2 years left. Update on Hegel Rd, no new information, still waiting on work to be completed and state inspections.
