

FANG ACTIVITY REPORT

March 2022

03/01 – FANG detectives utilized a confidential informant to buy crack cocaine from a known dealer in the Flint area. The investigation is ongoing.

03/02 – FANG detectives conducted an interdiction detail at the hotels in Flint Twp. One arrest was made for possession of crystal meth.

03/03 – FANG detectives assisted the ATF with a surveillance detail in the City of Flint. The detail was part of an investigation into a narcotics dealer.

03/04 – FANG detectives again assisted the ATF with a surveillance detail in the City of Flint. The detail was part of an investigation into the same narcotics dealer as the previous date.

03/08 - FANG detectives utilized a confidential informant to purchase ½ ounce of crystal meth from a dealer in the Flint area. The investigation is ongoing.

03/09 – After a several month investigation into a drug trafficking organization in the Flint area, FANG detectives executed search warrants on 4 different houses simultaneously. As a result of the search warrants FANG detectives seized 2 ounces of cocaine, 10 pounds of marijuana, 1 firearm and \$94,000 in cash. Two suspects were arrested and lodged.

03/10 – FANG detectives assisted the ATF with a surveillance detail in the City of Flint. The detail was part of an investigation into a narcotics dealer.

03/15 – FANG detectives were conducting surveillance when they saw a man exit a house holding a handgun. The man got into a vehicle and drove away. FANG detectives were able to get the vehicle stopped by a marked unit. The suspect was identified and was found to have an **outstanding homicide warrant**. The suspect was arrested and the handgun was recovered.

03/16 – FANG detectives utilized a confidential informant to purchase a ½ ounce of crack cocaine from a dealer in the Flint area. The dealer was identified and the investigation is ongoing.

03/18 – FANG detectives assisted DEA with the execution of 4 search warrants in the City of Flint.

03/22- FANG detectives utilized confidential informants to buy crack cocaine from 2 different dealers in the Flint area. Both investigations are ongoing.

03/24 – FANG detectives conducted a search warrant at the house of a known narcotics dealer in the Flint area. While searching the house FANG detectives located 582 grams of crystal meth, 5 grams of crack cocaine, 4 guns and \$2,725.00. One suspect was arrested and lodged.

03/28 – FANG detectives assisted Grand Blanc Twp. with the execution of 2 search warrants. As a result, 1 suspect was arrested for assault with intent to murder (AWIM) and 1 suspect was arrested for Armed Robbery.

03/29 – FANG detectives conducted a search warrant at the residence of a well-known narcotics dealer in Burton City. A small amount of cocaine and cash were recovered. This was the third time in 2 years that FANG detectives have arrested this suspect for selling narcotics.

03/30- FANG detectives executed a search warrant at the residence of a suspected cocaine dealer in the Flint area. FANG detectives seized crack cocaine, 2 guns and \$800.00 in cash.

Also on this date, FANG detectives utilized a confidential informant to purchase crack cocaine from a dealer in the City of Flint. The investigation is ongoing.

03/31- FANG assisted the Thumb Narcotics Unit (TNU) with the dismantlement of a meth lab.
