The work for this project will be done in phases. First phase will be the tree removal, the road commission is going out for bid. The total project approved cost is 1.2 million for the tree removal, ditching and paving. They will engineering sidewalks in the plans but the sidewalks will not be funded with this project. Estimated time for paving to start is 2025.
