Background: The Augusta Engineering (AE) requested on-call professional services from Engineering Professional firms specialized in natural resource protection regulatory compliance, permitting, design & construction support. Presently there is significant regulatory involvement & oversight in infrastructure project design and construction. Key emphases are protection of natural resources from further degradation as result of infrastructure improvements and maintenance construction activities. In addition, there is natural degradation of streams and its feeding watershed basin. In addition, NEPA compliance is a federal requirement to receive federal funding to support infrastructure improvements. AE has several roadway & drainage projects that are partially funded by Federal funds with the potential to receive additional federal funding. AE has continuous needs for subject specialized services and having a qualified experienced firm on board as an extension of AE inhouse workforce provides greater opportunities for securing federal funds.

Analysis:Proposals were received on November 4, 2024. Received proposals were
evaluated based on criteria outlined in the request for proposals (RFQ)
document and ranked accordingly. Pond and Company and HGC, LLC dba
RES Environmental Operating Company, LLC ranked two top rated firms
and being the selected firms.
