RECITALS

This is the twentieth (20th) Work Authorization to the PROFESSIONAL SERVICES TERMS AND CONDITIONS OF AGREEMENT dated effective October 17, 2023 between the CLIENT and CONSULTANT ("CONTRACT").

AGREEMENT

1. Services to be provided. The Scope of Services includes: all work, services, materials, equipment and supplies necessary to provide Construction Administration, Construction Observation and testing services for the rehabilitation of Standard Aero's ramp – Phase II ("THE PROJECT").

The pavement adjacent to and around Standard Aero's Facility is the lowest quality pavement on Augusta Regional Airport's (AGS) Airfield. In 2018, the area was rated at an overall Pavement Condition Index (PCI) of less than 55. A PCI less than 55 deems that the pavement is at a point of needing "Major Rehabilitation" and/or "Reconstruction." Phase I of the rehabilitation was completed in 2022/2023. Work includes but is not limited to Mobilization, Airfield Safety and Traffic control, Erosion control, the demolition of approximately 2700 square yards of asphalt pavement, the paving of approximately 500 tons of asphalt pavement along with new pavement markings and site improvements

2. Schedule. The project shall be completed within a 60 calendar day schedule.

3. Consideration. These services shall be provided for the lump sum / not to exceed amount of \$153,081.79. Services will be billed on a percentage complete basis by task. A breakdown of the fee is included in Attachment B. Progress payments shall be made in accordance with the CONTRACT.
