Background: Mead & Hunt submitted the 2025 Final AIG Grant Application to Joseph

Robinson and Gaethan Amedee at Atlanta ADO in June. This grant included the costs associated with the design services required to construct Taxiway Connectors A4 and G2, extend Taxiway G, Realign Taxiway A, and mitigate the existing "Hot-spot" at Taxiway E. The FAA has agreed to fund the project applied for in the amount of \$1,284,475. Augusta Regional Airport and Augusta-Richmond County received this grant on September 15th. The grant

was formally executed by Mayor Johnson on September 16th.

Following the execution of the FAA AIG Grant, GDOT Grant #73 was submitted to AGS and the City of Augusta for review and execution. Prior to

this Commission meeting, the Grant was executed by Mayor Johnson.

Analysis: Augusta Regional Airport and the City of Augusta have received a Georgia

State Grant through the Georgia Department of Transportation (GDOT) in the total amount of \$1,352,079.45. This grant is proposed to fund project(s) in fiscal year 2025. The grant is approved for the following project at Augusta

Regional Airport:

• Grant #73 - New Taxiway Connectors & Taxiway E Hot Spot

Mitigation – Design

The maximum obligation by GDOT in FY 2025 is \$33,801.99. The remaining cost of the project will be funded through FAA AIG Grant Funds totaling \$1,284,475.48 and Airport Enterprise funds totaling \$33,801.99.

Financial Impact: This grant will be funded via FAA AIG funds at a 95/5 split between federal

and local funds (\$1,284,475.48 - FAA; \$33,801.99 - GDOT; \$33,801.99 -
