Caption:	Approve the continued funding of the current On-Call Field and Laboratory Testing for Soil and Construction Material, and Geotechnical Inspection and Investigation (CMT_Geotech) Services contract in the amount of \$622,192.00 for 5th Street, 6th Streets, 13th Street, Telfair Street, and Greene Street Improvements Projects. AE/RFP 19-179
Background:	The 5th Street, 6th Streets, 13th Street, Telfair Street, and Greene Street Improvements are projects from the “Approved Investment List” of TIA that was approved by voters of the CSRA on July 31, 2012 referendum. These are Band 3 projects and TIA funds are allocated for construction. These projects are in construction. Field and Laboratory Testing for Soil and Construction Material, and Geotechnical Inspection and Investigation Services are integral parts of construction activities to ensure improvements quality control, quality assurance and construction per design. Construction quality assurance & quality control (QA/QC) are essential to construction of good roads and is a TIA program requirement. On August 2019, commission approved award of CMT_Geotech Services contract with Atlas (ATC Group Services LLC), Matrix Engineering Group, Inc. (MEG), and MC Squared, Inc. (MC2) being the selected firms. Atlas assigned to Broad Street construction, MC2 assigned to 5th & 6th Streets construction, and MEG assigned to 13th, Telfair, & Greene Streets.
Analysis:	AE has limited inhouse resource to provide needed subject services. The assistance of outside construction services functions as an extended arm of AE and helps with ensuring a quality finish product and meeting TIA construction QA/QC requirements. Subject projects are in construction and assigned firms are providing CMT_Geotech services to these projects. Continuity of these firms services is essential until completion of these

projects construction. Requested approval of supplemental funds is needed for continuity of these services.

Financial Impact:

Funds are in amount of \$622,192.00 are available as follow:

\$71,560 (5th & 6th TIA Project funds), \$150,850 (Greene TIA Project funds), and \$399,782.00 TIA-Discretionary funds.

Alternatives:

Do not approve and find alternative way to provide required CMT_Geotech, Construction QA/QC Services and meet TIA construction QA/QC requirements.

Recommendation:

Approve the continued funding of the current On-Call Field and Laboratory Testing for Soil and Construction Material, and Geotechnical Inspection and Investigation (CMT_Geotech) Services contract in the amount of \$622,192.00 for 5th Street, 6th Streets, 13th Street, Telfair Street, and Greene Street Improvements Projects.
