Background: The Barton Chapel Road (Deans Bridge-Augusta West Pkwy) Improvements

is a project from the "Approved Investment List" of TIA2 that was approved by voters of the CSRA in June 9, 2020 referendum. The Barton Chapel is a Band3 project. The project improvements consist of improving roadway safety by resurfacing, reconstructing the existing curb and gutter, targeted sidewalks replacement and improving the storm water system. The project will improve pedestrian safety at intersections with new high visibility crosswalks. New street landscaping will be provided, where possible, to enhance pedestrian use and improvement of roadway aesthetics. The project is in the design concept development phase. The roadway crosses CSX tracks warranting CSX design coordination & permitting to ensure proposed design meets railroad requirements of tracks safety and passing trains safe mobility and a safe

construction zone.

Analysis: Railroad coordination is required to ensure rail tracks safety and advance the

project construction schedule. Augusta would be required to enter into an agreement that Augusta will pay the estimated amount of \$52,500.00. This is a cost that is required to be paid by the Augusta, GA to complete the needed

engineering review.

Financial Impact: Project TIA funds.

Alternatives: 1). Do not approve and find alternative to reimburse CSX and complete the

TIA project.

Recommendation:

Approve entering into an agreement with CSX Transportation, Inc. stating that Augusta, GA will pay for the Preliminary Engineering and Review for the Barton Chapel Road (Deans Bridge Rd. to Augusta West Pkwy) Safety and Operational Improvements Project in accordance with the estimate \$52,500.00.
