Project Name: **Drinking Water Renewal Assistance**

Goodwyn Mills Cawood, LLC (GMC) is pleased to submit our proposal to assist the Augusta Utilities Department (AUD) with the renewal of the following permits:

Filter Backwash Discharge	GAG640000	12/31/25	7/4/25
Groundwater Use	121-0007	12/22/25	6/22/25 ^{1,3}
Operate Public Water System	CS2450000	1/5/26	7/4/25 ²

¹ Newer groundwater permits specifically require renewal submittal 180-days prior to expiration

² Permit does not specifically state renewal is required 180-days prior to expiration

³ Falls on a non-business day, may require earlier submittal

We propose the following tasks to renew the above-described permits within the timeline required by the Environmental Protection Division (EPD). Completion of the tasks by the required deadline will be dependent on AUD providing required documentation in a timely manner for the completion of the permit applications as well as timely review and signature of renewal documentation.

Task 1: Permit to Use Groundwater – 121-0007

EPD now requires submittal of the renewal application 180-days prior to the expiration of the permit, which falls on a Sunday. As a result, GMC recommends submittal of the renewal application and associated documentation no later than **6/19/25**.

Task 2: Permit to Operate a Public Water System – CS2450000

GMC recommends submittal of the renewal application and associated documentation no later than **7/3/25**.

Task 3: Filter Backwash Discharge Permit – GAG640000

GMC recommends submittal of the renewal application and associated documentation no later than **7/3/25**.

Please note, this renewal must be submitted through the Georgia EPD Online System (GEOS). AUD must authorize GMC as a “PREPARER”. This will allow GMC to prepare the application. Once the application is prepared, GMC will notify AUD that the application is ready for review, signature, and submittal, which must be completed by the Responsible Official (RO).

Fee

GMC proposes to complete the above scope of work for a lump sum fee of **\$20,000**.



Invoicing for the project will be submitted to AUD on a monthly basis as the work progresses. Extra Services, if ordered by AUD will be billed on a time and material (T&M) basis in accordance with GMC's current Standard Rate and Fee Schedule in effect at the time of the services. The 2025 Standard Rate and Fee Schedule is included for your reference.

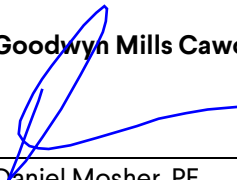
